SE drops appeal over attorney fees

The Sibley East Public Schools have voluntarily dropped its appeal to the Minnesota Court of Appeals to recover \$33,243.25 in attorney fees in connection with a lawsuit brought forth by rural Gaylord resident Nathan Kranz.

"The district felt that Judge Eide made it clear in his opin-

ion that the costs would not be inclusive of attorney fees," said Sibley East Superintendent Jim Amsden. "It was not deemed prudent to continue to expend district resources to pursue the payment of attorney fees given the position of the court."

"Our side is pleased with the school district's decision to drop the appeal," said Kranz. "I think they saw the

futility of their efforts."

The Sibley East School Board, earlier this year, approved a motion to authorize and direct Knutson, Flynn and Deans to file a motion on behalf of the school district for the reimbursement of attorneys' fees, costs and disbursements from Kranz in the district court election contest.

The Honorable Kevin W. Eide, in a ruling released on

Wednesday, April 1, denied the motion to recover the attorney fees.

In the same ruling, however, Judge Eide also ruled that the Sibley East Public Schools were entitled to the recovery of its costs of \$422.

In his memorandum, Judge Eide said that the "legislature specifically crafted Minnesota Statute 209.07 to provide for payment of the 'costs of the

contest,' not the 'costs of the contest and attorneys' fees.' This Court will not read the statute to include attorneys' fees where such a specific provision was not made. As a result, Contestees are entitled to recovery of their costs of \$422, and their motion for attorneys' fees is otherwise respectfully denied."

Sibley East filed an appeal with the Clerk of Appellate

Court at the Minnesota Judicial Center in St. Paul on Wednesday, April 29.

The appeal was voluntarily dismissed on Friday, June 5, according to the Minnesota Court of Appeals website.

Superintendent Amsden updates the Chamber on upcoming school projects

Sibley East Superintendent Jim Amsden presented an update on the upcoming school building projects to the Arlington Area Chamber of Commerce on Monday afternoon, June 8.

Amsden presented a "very preliminary" sketch of the floor plan for the building project at the Arlington school site. This building project will include the renovation of the school with additions in Arlington for students in grades 6-12.

The goal is to open the newly renovated school in Arlington for the 2017-2018 school year. The transformation of the large gym into an auditorium, however, will not be completed until the winter of the 2017-2018 school year.

Meanwhile, the new elementary school in Gaylord for students in grades PreK-5 will open for the 2017-2018 school year.

The construction of the new elementary school is contingent upon a land swap agreement between the Sibley East Public Schools and the City of Gaylord. Amsden said the Gaylord city attorney is currently in the process of drawing up the agreement. He added that the agreement will be completed late this summer or early this fall.

The land swap agreement, according to Amsden, does not include the current bus garage in Gaylord or the property located north of the existing bus garage.

Amsden said there will be separate budgets for the two school building projects which will total approximately \$43 million.

Other Business

The Chamber, in other business, unanimously approved a motion to update the informational guide for the Arlington community.

In another matter, it was announced that the Arlington Dollars have no expiration date and can be cashed in at any time.

Lyle Rud reported that the Chamber plans to sell 1,500 raffle tickets for \$10. Five thousand dollars of the profits will go toward the Arli-Dazzle Parade while the remaining \$2,500 will go toward other Chamber projects. The plan is for the Chamber to purchase \$3,000 worth of prizes from local businesses.

In other news, the Arlington Area Chamber of Commerce will hold its next regular monthly meeting at the Emergency Services Building at noon Monday, July 13, according to Chamber President Kevin Lindstrand.

Arlington Garden Club celebrates 85 years

On July 27, 1930, the first meeting was called to order at the Emma Scharping home to organize a garden club. Since that time the club has been growing and nurturing garden areas in and around the Arlington area. In the early years, the club started the garden competition and flower exhibits at the county fair. The flower exhibits at the fair are still part of the club's yearly events.

The club has been involved with the Minnesota Horticulture Society throughout its history. In the early years, the club was involved in submitting its organizational plans to the State Society and in 1979 won the Grand Champion awards for its club program. The club is still making a booklet each year giving its yearly plans of garden events and meetings. This past year the Arlington Garden Club hosted the annual district meeting at the Senior Citizens Building. The meeting consists of speakers on various garden topics, plant sale, district meeting and a luncheon.

The goal of the club is to beautify the community, to

aid in the promotion and protection of trees, plants, birds and insects and to promote civic improvements. The club flower is the petunia. Club colors are green and white. The motto is "We will pass this way but once. Let us beautify the way we go, that the whole world will know the way we went."

Currently, the club has 22 members in addition to three honorary members. The club meets the first Tuesday of the month in the member's home, Liberty Station and/or the library depending on the topics being presented. Demonstrations and discussions range from new plant varieties, preparation of flowers for display, how to grow new and existing plants, flower preserving, garden art projects, and new and improved gardening techniques. The club also has many garden tours and outings planned each year.

This year the club took on a new project at Memorial Park in front of the hospital. A raised bed was put in place with a rendition of the American flag in red, white and

blue annual flowers. This was made possible by the donations of various clubs in Arlington. The club recognizes the VFW, American Legion and Women's Auxiliary for their monetary contributions to make this project a reality. Residents are encouraged to visit the park and see all the gardens on display. To keep all of the projects thriving, the club hosts an annual plant sale. It has been held at the Liberty Station on Highway 5 the past several years. The club is appreciative to the community for its present and past support.

To celebrate this milestone in its history, the Arlington Garden Club will be hosting garden tours in the area from 9 a.m. to 1 p.m. Saturday, June 27. To get the map, a nominal fee will be taken at the Senior Citizens Building at Four Seasons Park. There will be flower arrangements on display, some plants for sale, and Arlington Garden Club history displays with pictures dating back to 1930 to the present. Refreshments will also be served. To show its appreciation to the com-

County to proceed with Ditch #29 repair

The Sibley County Board, during its regular meeting on Tuesday morning, June 9, authorized Bolton & Menk, Mankato, to proceed with the County Ditch #29 repair to return the ditch to the way it was originally intended.

Approximately 25 area landowners were present to voice their views when the Board accepted the final engineer's report presented by Bolton & Menk, accepted the ditch viewer's report, and by a 4-1 vote directed Bolton & Menk to prepare the bid specifications and a timeline to award the contract to repair

the ditch. County Commissioner Bobbie Harder voted against it.

Duane Hansel of Bolton & Menk expects to get bids within 60 days, but repair work will not begin on the project until the crops are out of the field.

In other public works news, the Board accepted a quote

from Barnett Bros., Inc., Kilkenny, for the installation of the box culvert on CSAH 6 north of the Jessenland church. Barnett Bros, Inc. came in as the low bid out of four bids.

The Board also approved a contract with Pam Hahn to provide training and mentoring for the new Sibley County

Public Works Department accountant. Hahn will be paid \$31.60 per hour for a maximum of 80 hours. Hahn resigned as Public Works accountant on May 22. However the contract will allow her to train and mentor the new accountant. The Board approved the contract by a 4-1 vote, with Harder voting no.

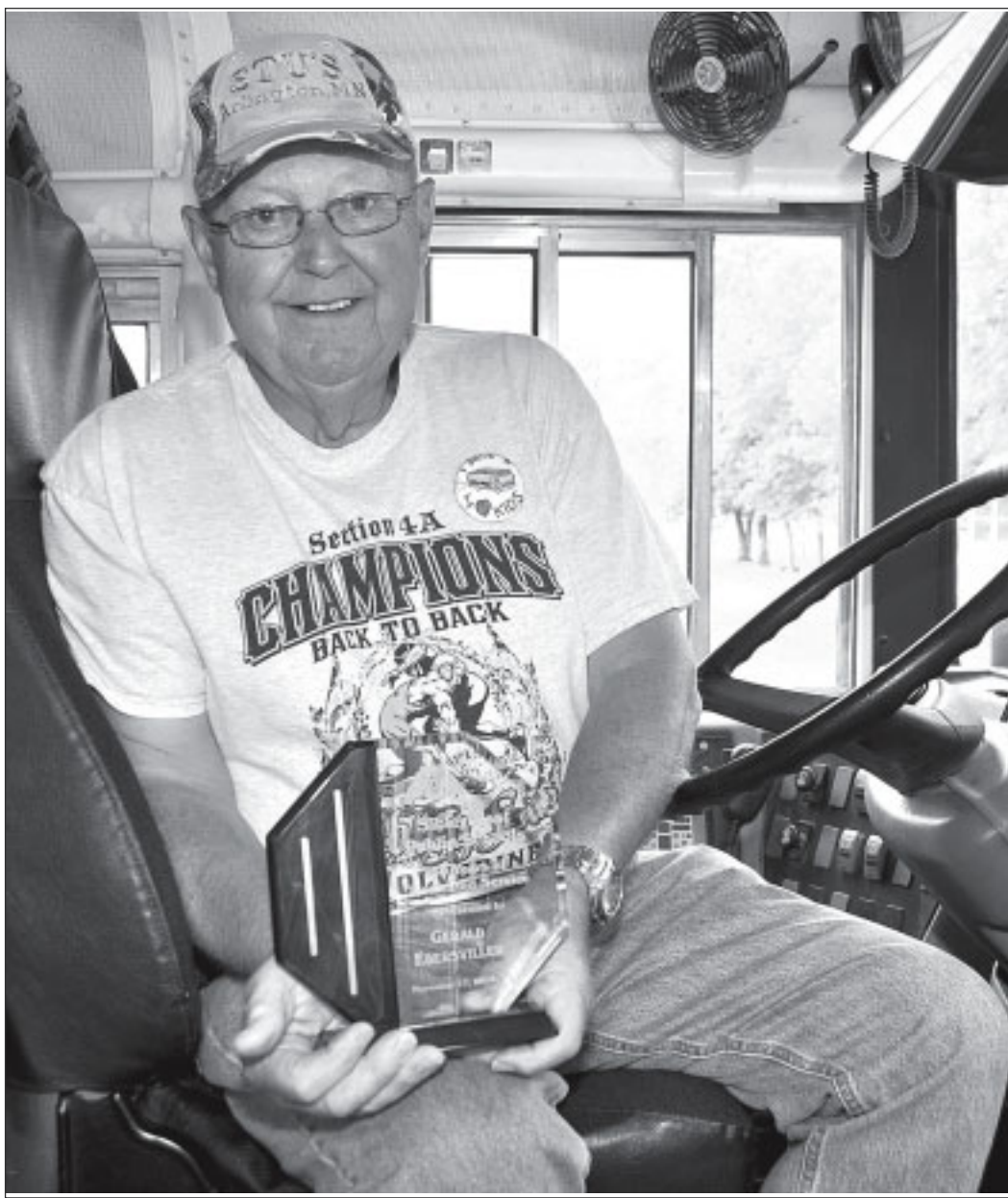

It is often times difficult to plan around the weather as inaccurate forecasts and predictions are a recurring theme in the state.

They want and encourage people to tune into their local television channels and see the latest coverage on the storm of the century. 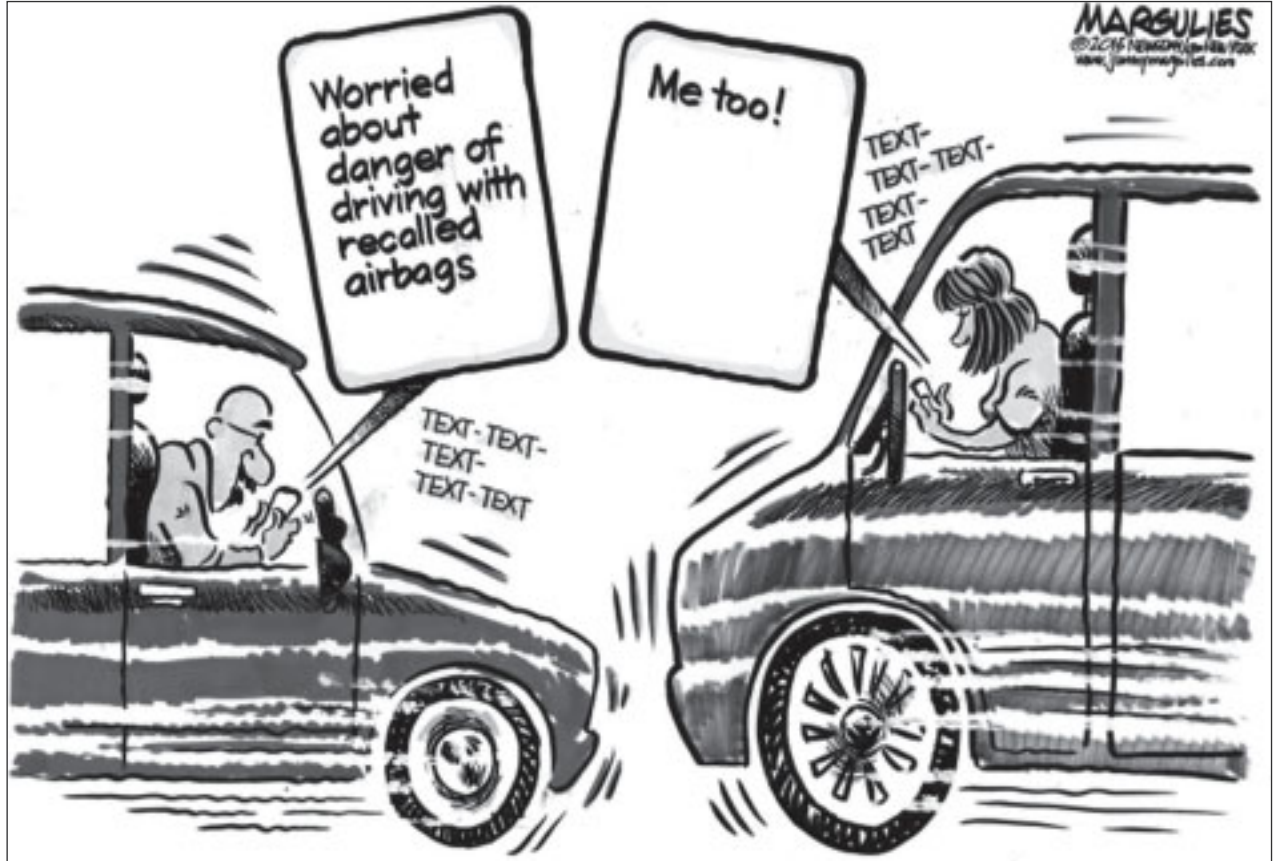

Fix the lack of access to diabetes education

To The Editor,

Diabetes is a significant problem for the people of Minnesota. According to the Centers for Disease Control, the rate of diabetes in the state has increased from 4.0 per 100 adults in 1994 to 6.8 per 100 adults in 2012.

A diabetes diagnosis – more than 26 million Americans have already received one, and nearly 80 million more are at risk – can inspire uncertainty and fear. Diabetes is among the leading causes of blindness, stroke, lower limb amputations, heart disease and stroke in adults. It has been associated with higher rates of certain cancers.

Diabetes Self-Management Training, or "DSMT" is a process by which people with diabetes learn how to manage their condition. The results are not to be taken lightly; actively and effectively managing diabetes can often reverse or dra-

matically slow the onset of diabetes related complications and improve the public health.

In addition to improving an individual's quality of life, diabetes education is also a simple dollars and cents issue. When people with diabetes learn how to effectively manage their blood glucose levels, they have fewer instances of these life-threatening diabetes-related complications, trips to the emergency rooms, and hospitalizations. Until such time as we have a cure for diabetes, diabetes education/DSMT is arguably the most effective way to address the diabetes crisis in Minnesota by helping ensure that patients are able to manage this terrible disease and adhere to the treatment regimen prescribed by their doctor.

Tragically, diabetes education is a significantly underutilized benefit in the Medicare program for older

adults. Legislation currently pending before Congress, the Access to Quality Diabetes Education Act (S. 1345, H.R. 1726), seeks to change that. The bill would recognize specially credentialed diabetes educators as DSMT providers in the Medicare program, a provision that does not currently exist and that, therefore, limits access to diabetes education.

Studies show the bill would save the federal government up to \$2 billion in health care spending.

Senator Amy Klobuchar and Senator Al Franken are lead sponsors of this bipartisan bill. We urge their colleagues in Minnesota to support the bill, so that it will become law. This small, cost effective measure will save countless lives.

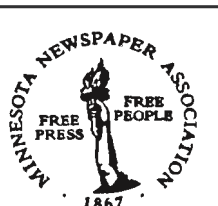

Update presented on tax collection

Sibley County Treasurer Mary Fisher updated the Sibley County Board on the 2015 taxes collected. The update occurred at the regular meeting on Tuesday morning, June 9.

Through May 22, Sibley County has collected \$15,687,431.09, which is more than half of the total of \$28,205,384.91 due this year. Fisher said that it is typical to collect more than half of the taxes due by this time because personal property taxes are due in full.

Fisher also updated the Board on the county investments and said that interest rates are "a bit better" than they have been.

Court Administration

Court Administrator Karen Messner updated the Board

on some changes in court administration. Beginning July 1, the Minnesota State Patrol will be issuing e-citations and the courts will be moving toward mandatory e-filing. Messner reported an increase in major criminal and petty juvenile cases in Sibley County. Judicial employees will move to "pay for performance" reviews." Messner also announced that she has been elected to a two-year term on the Judicial Council.

The Board approved the law library contact upgrade to tier two at a cost of \$483.00. The tier two level will allow for some extra services such as an annual visit to the Sibley County Law Library by the State Law Librarian, evaluation of existing collections, creating a list of free legal research services and access to the 1-800 State Law Library desk.

Smoke-Free

The Board approved making Sibley Estates East/West smoke-free beginning Jan. 1, 2016. Kelly Pierson, Sibley Estates East/West Community Manager, stated that they surveyed residents and found that 72 percent of residents were in favor of having no smoking in the building hallways or units.

Ditch #70

The Board also approved change order number three to the contract for establishment of Ditch #70 between Sibley County and Schneider Excavating and Grading, Inc. of Norwood Young America. The change order is for the purpose of increasing the construction cost by \$9,432.50 to a revised contract of \$198,092 due to delays in permits.

DNR approves new deer population goals covering 40 of 128 permit areas

New deer population goals have been approved by the Minnesota Department of Natural Resources for large portions of northeastern, north-central and east-central Minnesota, covering 40 of 128 deer permit areas in the state.

“These new goals will result in management to increase deer numbers in relation to last year’s levels in most of the 40 permit areas,” said Steve Merchant, wildlife populations manager. “The new goals largely reflect the desires shared by stakeholders who participated in the deer goal setting process and generally reflect the public feedback we’ve heard during the past few years.”

As a result of this process, 85 percent of the 40 areas will be managed for populations higher than those experienced in 2014; the remaining will see no change.

Comparison To Former Goals

Of the 40 deer permit areas with new goals, 26 will be managed for deer densities higher than those established by the previous goals; eight will be managed at similar densities to former goals; and six will be managed for densities below former goals. More information about the goals for each deer permit area can be found online.

With respect to the four advisory team recommendations not accepted by the DNR, the agency chose more moderate population increases to better reflect the preferences suggested by hunter and landowner survey data and public input; allow more deer to be harvested; and minimize anticipated deer damage to agricultural lands and forest habitat.

Goals are intended to be in place for three to five years. The DNR shortened the goal timeframe to allow more frequent opportunities to revisit and adjust goals with input from stakeholders.

Goal-Setting Process

This is the third year the DNR has worked with citizens and stakeholders to reassess and re-establish deer population goals in portions of the state. Goals for southwestern and portions of northern Minnesota were set in 2012. Goals for southeastern Minnesota were set last year.

DNR will postpone goal setting in the remaining 54 deer permit areas scheduled for consideration in 2016 until the current legislative audit of Minnesota’s deer population management program is complete.

Roadsides are important habitat for pollinators and pheasants

People who own or manage land along Minnesota roads and highways are urged to delay roadside mowing until the beginning of August, according to the Minnesota Department of Natural Resources.

“A quarter to a third of all the pheasants in the state are hatched in roadsides,” said Nicole Davros, DNR upland game project leader. “Roadsides provide more than 500,000 acres of nesting and chick-rearing habitat in southern and western Minnesota.”

This year, pheasants will be hatching mostly in early-to mid-June. Chicks need at least two to three weeks to have any chance of escape from mowers. While mowing can delay or prevent nesting, so can other disturbances including burning, tilling, grazing and spraying herbicides.

“People can influence the abundance of local wildlife populations by protecting roadside habitat in the summer months,” Davros said. “Roadside vegetation is especially important in intensively row cropped regions where there is little other undisturbed grassland habitat available.”

At sites where noxious weeds are a problem, the DNR recommends that landowners use spot mowing or spraying for treatment. If landowners are worried about traffic safety, mowing should be limited to a narrow strip adjacent to their mailbox or driveway to reduce the likelihood of disturbing a nest or brood.

Pheasant hens will make from one to four attempts at nesting during the spring nesting season, but will only hatch one brood per year. The majority of nests (about 60 percent) hatch in June, but re-nesting attempts can stretch the nesting season out through July. By Aug. 1, the reproductive season is over for most pheasants with the exception of a few late re-nesting attempts.

A nesting hen lays eggs at a rate of about one per day. Nests contain an average of 10 to 12 eggs. The incubation period is 23 to 28 days and starts after all eggs have been laid. The hen remains on the nest, leaving only briefly to feed.

Wide-Ranging Benefits Of roadside Habitat

Roadsides also provide important habitat for mallards, teal, gray partridge, grassland songbirds, pollinators, frogs and turtles.

Roadsides with native wildflowers benefit native bees. Research has shown that the width of the roadside and the proximity to traffic does not matter to bees. Minnesota bee keepers place a high value on roadside wildflowers. Loss of habitat is a critical cause of the decline in both wild bees and honeybees.

June is Rail Crossing Safety Awareness Month

June is Rail Crossing Safety Awareness month and the Minnesota Department of Transportation and Minnesota Operation Lifesaver remind citizens about the importance of safety around trains.

"Minnesota ranks in the top 15 states with the most highway-rail grade crossing incidents," said Sheryl Cummings, Minnesota Operation Lifesaver executive director. "People need to make safer decisions around tracks and trains so we can reduce fatalities and injuries."

Most crossing accidents occur because motorists and pedestrians ignore warning signs, signals or safety gates.

According to the Federal Railroad Administration, in 2014, 59 vehicles were involved in incidents with trains, resulting in 10 fatalities in the state. In 2013, there were 53 incidents, resulting in six fatalities.

There were eight injuries and fatalities of people trespassing on railroad property in 2014, compared to 10 in 2013.

MnDOT is spending \$6.5 million in state and federal funding this year for rail grade crossing safety to re-

duce train-related incidents with vehicles and pedestrians. Gov. Dayton's 2015 transportation bill includes an additional \$5 million over the next two years for rail grade crossing safety measures.

"Installing new crossing signals and gates and replacing older equipment help make each crossing safer," said Bill Gardner, MnDOT's Office of Freight and Commercial Vehicle Operations director. "But it's up to motorists and pedestrians to obey the law and not drive around gates or through lights."

Minnesota Operation Lifesaver offers free education to community and civic groups including law enforcement, first responders and driver's education programs.

MnDOT and Minnesota Operation Lifesaver offer these tips for drivers and pedestrians when crossing a track:

- Expect a train at any time. You can't be sure when a train may appear at a crossing, even if it's one you drive or walk across every day. Freight trains don't travel on a regular schedule and the schedules for passenger trains

can change. Always be alert, because trains can run any time of day or night, on any track, in any direction.

- Don't be fooled, the train is closer and faster than you think. In the same way that airplanes can seem to move slowly, a train may seem farther away than it really is. It's easy to misjudge a train's speed and its distance, especially at night. Don't take chances. If you see a train, just wait.

- Trains can't stop quickly or swerve—be prepared to yield. After fully applying the brakes, a loaded freight train traveling 55 miles an hour takes a mile or more to stop. A light rail train takes 600 feet to stop, and an eight-car passenger train traveling 80 miles an hour needs about a mile to stop. Even if the engineer can see you, it's too late to stop the train in time to prevent a collision.

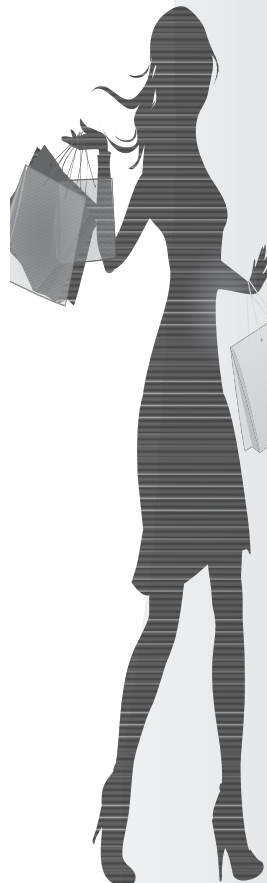
- Stop and wait when gates are down or lights are flashing. If the gates are down, the road is closed and you must stop and wait. That's the law. Continue across after the gates go up and the red lights stop flashing.

- Don't trespass on foot.

Tracks and the property alongside them are private property. Stay off railroad cars and tracks. It's illegal and, too often, it's deadly.

- Don't get trapped on the tracks. Never drive onto a railroad crossing until you're sure you can clear the tracks on the other side without stopping. If your car stalls or is trapped on the tracks, get everyone out right away, even if you don't see a train coming. Move quickly away from the tracks. If a train is coming, move in its direction as you move away from the tracks. If you run the same direction the train is going, you could be injured by flying debris when the train hits your car.

Proper timing of weed control in soybeans and corn is essential for maximum yields

Recent rain for many area corn and soybean fields will result in increased weed seedling growth and weed seed emergence. Thus this increased weed growth may present growers with more of a competitive weed problem if the weeds are not controlled through tillage or the use of herbicides. In order to control weeds that are competitive with a row crop such as soybeans or corn it is important to understand the principles of herbicides which have been applied after planting with a pre-emergence method.

Many growers ask "Will pre-emergence herbicides still have activity after remaining on the soil surface for several weeks?" The answer to this is generally "yes", and you can expect some activity from herbicide once rain finally moves it down into the soil. Herbicide can be lost from the soil surface via degradation, but dry soil conditions will limit the rate at which this occurs. The important issue is the emergence of weeds between

application and rainfall, which will generally require some type of post-emergence herbicide treatment even if the pre-emergence herbicides are finally "activated".

Critical Weed Free Period: Dr. Jeff Gunsolus, Extension Weed Scientist at the University of Minnesota indicates that weeds that emerge with corn must be controlled within 2 to 5 weeks after weed emergence to prevent a yield loss due to weed competition. Soybeans can tolerate 4 to 6 weeks of weed/crop competition. This period of crop tolerance to weed competition is decreased under high weed densities or environmental stresses such as low moisture or nitrogen levels. A good rule of thumb is to establish the endpoints for completing initial weed control operations for both mechanical and post-emergence herbicides in order to limit yield loss in corn and soybeans due to weed competition. In Minnesota we would recommend that initial weed control be accomplished by the V4 growth stage of soybeans and by the four leaf stage in field corn.

University of Minnesota research points out the best timing in Soybeans and Corn when applying glyphosate herbicide:

University of Minnesota research over a three year period of 2004 to 2006 at 5 locations in Minnesota found that in corn the combination of a soil pre-emergence herbicide followed by a glyphosate application to 5 inch weeds gave the best economic return which was slightly better than the 3 inch weed height. Glyphosate applications alone from the 3 to 5 inch weed height resulted in the highest yield. In soybeans glyphosate applications for both the pre/post and post-emergence timings gave the highest yields at the 5 inch weed height. Application of only glyphosate applied too early (less than 5 inch weeds) can reduce crop yield due to later emerging weeds. 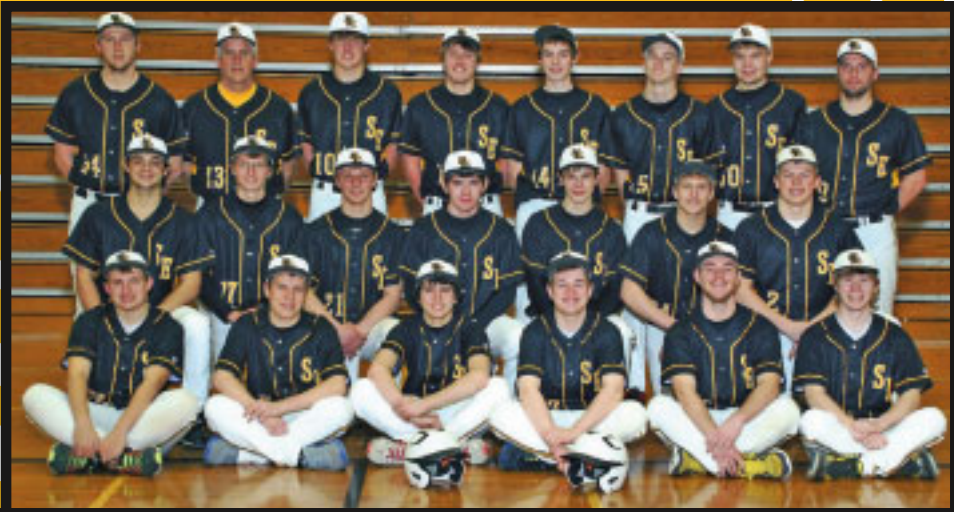
