Arlington City Council hires administrative assistant

The Arlington City Council, during its regular meeting on Monday night, June 18, unanimously approved a motion to hire Shannon Nix as the new administrative assistant for the City of Arlington.

City Council members

Michelle Battcher, Adam Cowell, Tom Hatlestad, Jim Heiland and James Jaszewski all voted in favor of the motion.

The Administration Department is in the process of doing the necessary background work on Nix, obtaining a computer for her use and fi-

nalizing her start date, according to City Administrator Patrick Melvin.

Nix will work 32 hours per week and will be paid \$14 per hour.

Revisions

The City Council, in other action, unanimously approved

a motion to approve revisions to the Lions Center Use & Rental Policy.

Under the revisions, the Arlington Lions Club will be allowed complimentary use of the facility.

The Lions Center Use & Rental Policy now reads, "In recognition of the very gener-

ous financial support, both in the initial construction of the Lions Center, and of the subsequent major renovation of the facility (in 2017) by the Arlington Lions Club, the City Council of the City of Arlington, hereby extends not only complimentary, Group 1 use of the Lions Center, but also

extends complimentary use of the Lions Center for the area Lions events hosted by the Arlington Lions including, but not limited to occasional Lions District meetings."

The Arlington City Council will hold its next regular meeting at 6:30 p.m. Monday, July 2.

Heavy Rain & Flooding

Some areas in Arlington experienced flooding after heavy rain on early Saturday morning, June 16. The community received anywhere from 3 1/2 to five-plus inches of rain over a couple of hours. The southeast part of town received 3 1/2 inches of rain while the northeast section of the community received four-plus inches. The west section of town received five-plus inches. The heavy rain flooded Fairview Park, pictured, and

threatened the Fairview Assisted Living facility. Gaylord received approximately 3 1/2 inches while Green Isle received as much as 2 1/2 inches of rain during the same period of time, according to reports. The heavy rain and flooding occurred four years after the torrential rain and major flooding in Arlington on June 19, 2014.

Board receives an update on County Road 9 by Arlington

Public Works Director Tim Becker recently informed the Sibley County Board that the Minnesota Department of Transportation (MnDOT) would like to replace the automated traffic recorder located north of Arlington on the west side of County Road 9. MnDOT is requesting to replace it after the county finishes resurfacing County Road 9. There is no cost to the county for this move. The County Commissioners approved the agreement.

Becker stated that Public Works has seal coated 32 miles of road and resurfacing has started on County Road 13 and they plan to start on County Road 9 around July 4.

County Commissioner Gary Kruggel asked if County Road 9 would be done by fair time, Becker stated that they hope to have it open during the fair. He stated that the bridge project will start on Aug. 6.

ty Board will discuss the proposals at their work session on Tuesday, June 26.

Court Administration

The County Commissioners approved a request to purchase LexisNexis software for the law library. Karen Messner mentioned that there would be about a three percent or \$11 increase each year. County Commissioner Bobbie Harder pointed out that this was paid for through library fees. Messner stated that yes, there is a law library fee on each citation, filing fee, etc. and that the county is not putting in any additional funds, but that she needed Board approval to purchase the software.

The County Board also approved the county law library program agreement with the State law library. Messner requested going with tier I, which includes just the statute books. With tier II, someone comes out to make recommendations for the county's law library, but Messner stated that the law library committee felt that tier I would be sufficient.

Messner also provided an update on the activity of Court Administration. She stated that they have a new hire, Teresa Giesen, who replaced someone that transferred to McLeod County. Giesen will be working with child support, guardian ad litem, conservatorships, orders for protection, and harassment.

The County Commissioners will hold their next regular meeting in Gaylord at 9 a.m. July 10.

Update On County Road 57

Becker reported that he attended the Winthrop City Council meeting on June 4 to discuss the County Road 57 project. He stated that there were approximately 15 to 20 people in attendance with various opinions about the project. Ultimately, the City Council tabled the approval of moving forward with the project until they are able to collect more information on the costs of relocating city utilities at County Road 57.

Becker also provided copies to the County Commissioners of the three proposals he received for plan development of an RV campground park at Clear Lake Park near Gibbon. The Coun-

Five-year-old girl is caught by passerby after hanging out window in Green Isle

A mother has been charged with one count each of child neglect and child endangerment after a passerby found her daughter hanging out of a second story bedroom window in Green Isle around 9 p.m. Thursday, June 14.

According to the criminal complaint, a concerned citizen called the Sibley County Sheriff's Department and stated that her son just caught a child who fell out of a second story window at the residence in Green Isle. The reporting party said she and her son

were driving by the residence. Her son then told her to stop and he quickly got out of the vehicle. They observed a child hanging from the second story window. The child then fell and her son was able to catch the child.

The child, according to the criminal complaint, brought the reporting party to the front of the residence and went inside and found the child's mother, April Grams, 47, asleep. The child told her mother, "Don't lock me in the room again."

When a deputy sheriff arrived on the scene and investi-

gated, he found that the door to the bedroom had a lock on the outside whereby the child could apparently be locked in her room, according to the criminal complaint. The window had locks on it, but the window had been opened and the screen had been cut.

The mother said she put the child in the bedroom and locked the door at 7:30 p.m., the criminal complaint said. The mother then went to sleep. There was no bathroom in the child's bedroom. However, there was a small Halloween pumpkin in the bedroom that had urine inside of

it. The child said that when she was locked in her room and had to use the bathroom, she would urinate in the pumpkin.

The deputy sheriff later made contact with the on-call social worker for the Sibley County Public Health and Human Service. It was determined that the child could remain in the residence if the lock was removed from the bedroom door. The mother removed the lock in the presence of the deputy sheriff who then cleared the call.

Installation is a part of MMPA Hometown Solar Grant Program

The sun is powering a new learning tool in Arlington. An educational solar array provided by the city's wholesale electrical supplier, the Minnesota Municipal Power Agency (MMPA), is now operating as part of energy education programming for Sibley East Public Schools. The array is located at Sibley East Middle/High School.

The five-kilowatt installation is part of MMPA's Hometown Solar Grant Program - an extension of its Energy Education Program for its 12 member municipalities, including Arlington. The solar array in Arlington provides an opportunity for stu-

dents and residents to learn about the characteristics and benefits of solar power. Information and data from the solar panels will be shared among Sibley East schools to support energy education in the classroom.

"The Sibley East learning community is grateful to be chosen as a partner in this energy education program with MMPA," said Jim Amsden, Superintendent.

"By sharing real-world data from our solar installation across multiple schools and grade levels, we can offer our students an important insight into solar power," Amsden said.

John Crooks of Shakopee, Chairman of the MMPA Board of Directors, said, "Hometown Solar is a great demonstration of how the Agency provides value to our member communities." Since 2010, MMPA's Energy Education Program has provided learning opportunities for more than 15,000 elementary school students in its member communities through classroom information, in-school assemblies, and tours.

The Arlington Electric Utility has served residential, commercial, and industrial customers in its service area since the early 1900s.

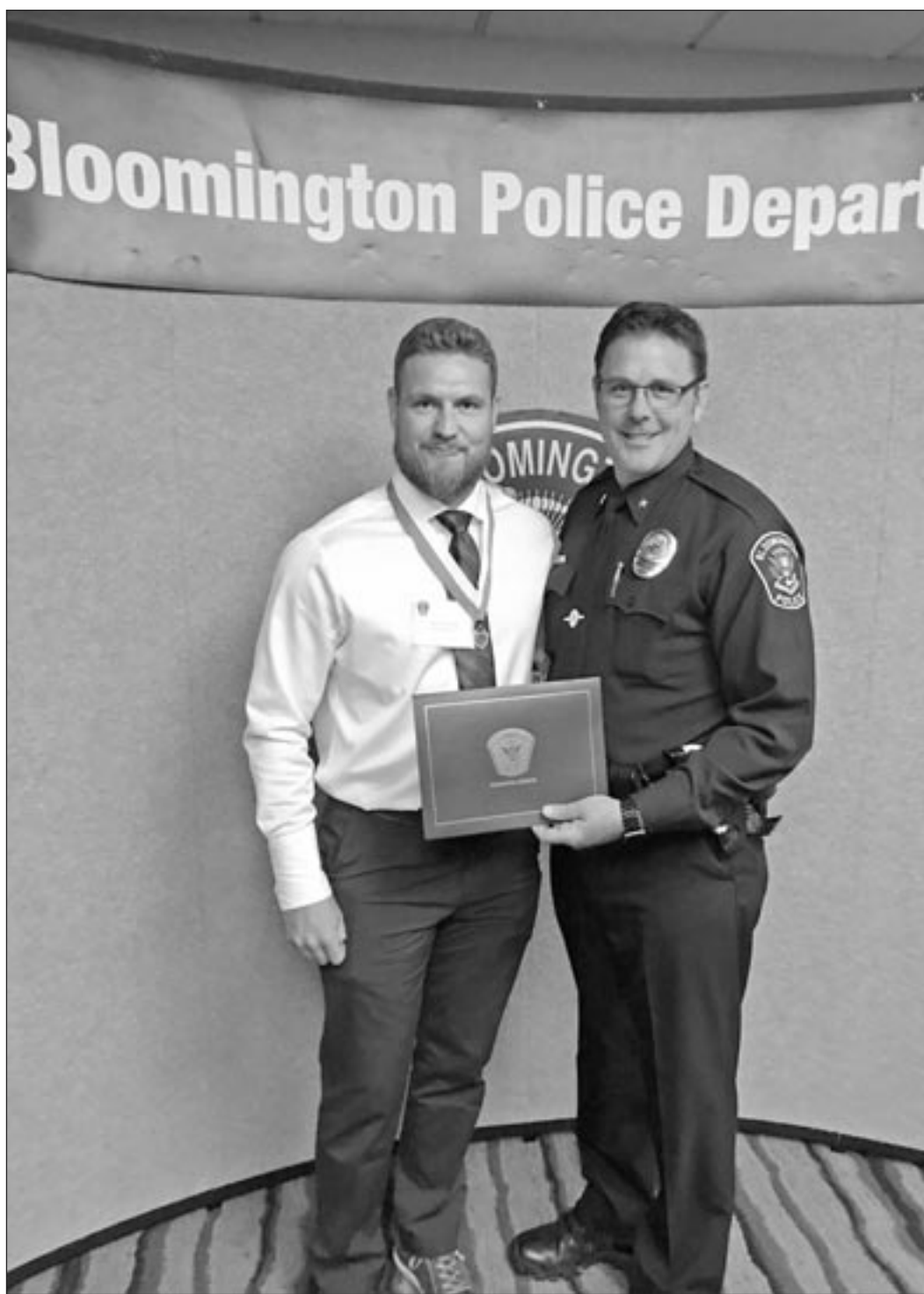

Trevor Schrupp is recipient of Citizen Commendation Medal

Trevor Schrupp, a 2011 graduate of the Sibley East Senior High School in Arlington, received a Citizen Commendation Medal and Certificate from the Bloomington Police Department on Thursday, June 7.

Schrupp, who is a personal training assistant manager at Life Time Fitness, heard a medical emergency call go off over the walkie talkie and ran down to the fitness floor around 5 p.m. Thursday, March 8.

Schrupp and another mem-

ber checked the vitals of a male who had an apparent heart attack. They found the male was not breathing and had no pulse.

"I immediately ran and got the AED while another member started the compressions," said Schrupp, who graduated from Minnesota State University in 2016. "We put the AED on and followed the instructions. It took two shocks before it registered a heart beat and by the time the paramedics arrived. When the gentleman left, he was breathing and had a pulse."

Schrupp said it was a very

unreal feeling to save someone's life.

"I feel absolutely amazed and grateful that I was able to help," Schrupp said. "During the event, you don't think about what you are actually doing. You just do what you were trained to do. I am happy that this gentleman is alive because it could have easily gone the other way."

Trevor is the son of Dan Schrupp, Arlington, and Leah Schrupp, Arlington.

He is also the grandson of Bob and Liz Schrupp, Arlington, and Judy Gaere and Bob Pautsch, Arlington.

Phone and Internet Discounts Available to CenturyLink Customers

The Minnesota Public Utilities Commission designated CenturyLink as an Eligible Telecommunications Carrier within its service area for universal service purposes. CenturyLink's basic local service rates for residential voice lines are \$15.96-\$18.76 per month and business services are \$34.61-\$43.29 per month. Specific rates will be provided upon request.

CenturyLink participates in a government benefit program (Lifeline) to make residential telephone or qualifying broadband service more affordable to eligible low-income individuals and families. Eligible customers are those that meet eligibility standards as defined by the FCC and state commissions. Residents who live on federally recognized Tribal Lands may qualify for additional Tribal benefits if they participate in certain additional federal eligibility programs. The Lifeline discount is available for only one telephone or qualifying broadband service per household, which can be on either wireline or wireless service. Broadband speeds must be 15 Mbps download and 2 Mbps upload or faster to qualify.

A household is defined for the purposes of the Lifeline program as any individual or group of individuals who live together at the same address and share income and expenses. Lifeline service is not transferable, and only eligible consumers may enroll in the program. Consumers who willfully make false statements in order to obtain a Lifeline discount can be punished by fine or imprisonment and can be barred from the program.

Our View: Don't believe everything you read on the Internet

News events in Arlington and Green Isle, for good or bad, are sometimes placed on websites by state or regional newspapers and tv/radio stations. That means the news coverage is out on the Internet for everyone to read.

The down side to this coverage is that it frequently lacks accurate information. The nuts and bolts of the articles are generally accurate, but the finer details are often incorrect. The date of one recent news event was wrong and the incident was investigated by the sheriff's department and not by local police.

What makes matters worse is that people cut and paste these articles onto their Facebook page for even more people to see the misinformation.

The *Arlington Enterprise* is not perfect by any means, but it strives to report the real news with accurate information. That means covering public meetings, talking to public officials who know the facts, looking at initial complaint reports at the police department and sheriff's department, and running to the courthouse to obtain criminal complaints.

When the local newspaper falls short in that endeavor, it will publish a correction or clarification which is seldom found on the Internet.

People can count on their hometown newspaper to accurately and fairly cover the news in the Arlington and Green Isle area each and every week of the year.

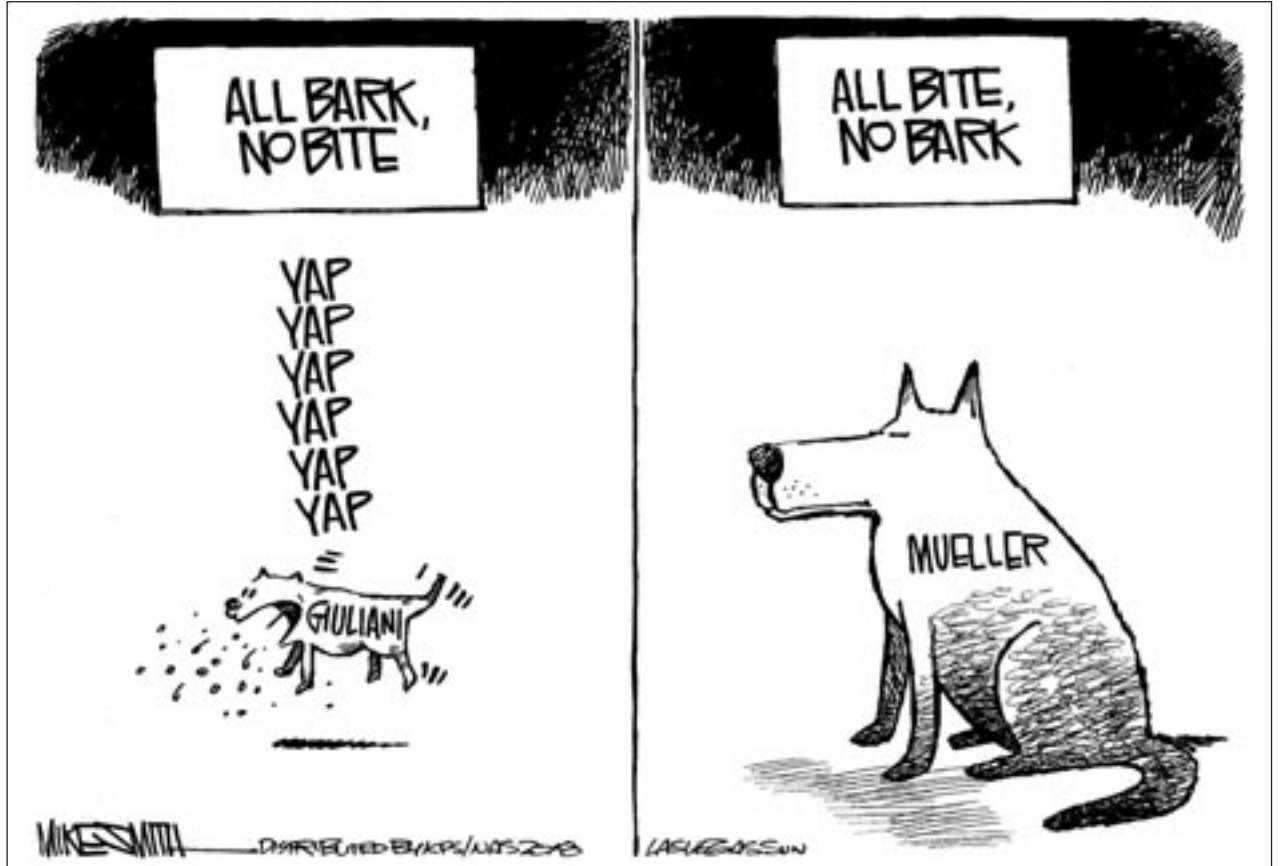

Tax subsidy is just the tip of the iceberg

To The Editor,

Today is the day (Wednesday, June 20) when the Gaylord City Council will hold a public hearing on the proposed medical school TIF plan. A tax subsidy that will give \$5.7 million tax dollars to Phil Keithahn and his New Jersey development group (Danza Group of Minnesota, LLC) over the next 25 years. If approved, this will be the tip of the tax subsidy iceberg that is about to hit the City of Gaylord and is the beginning of a well-crafted web of corporate greed that our elected officials want to convince taxpayers will benefit the City of Gaylord and Sibley County.

As I read through the 105 pages of this tax subsidy material you can find in the city council meeting packet I found some disturbing facts hidden in the pages of all the information most of us will never bother to read, and there are people in positions of leadership in this city that like it that way. Because what we don't know, can't hurt them. Here are just a few facts that whether you care about or not, will affect you in some way, some day:

1. \$70,000,000 in bonds will be issued by a company known as the Wisconsin Public Finance Authority (PFA), who will own the property and lease it to Keithahn's private management group.

2. Keithahn's private management group established in June 2017,

known as the Minnesota Medical University, LLC, will enter into an agreement with PFA to operate the medical school PFA will own.

3. In May 2018 Keithahn established another private management group known as the Courtside Housing of Gaylord, LLC to develop and manage the housing facility that will be part of the medical school owned by PFA.

4. When this whole tax subsidy package is all said and done the development group's profit margin will increase by 1.1 percent (5.1 percent instead of 3.9 percent) on the backs of hard working taxpayers in Sibley County and especially in the City of Gaylord, as a result of this 25-year tax subsidy. It's called "cash on cash return," a fundamental concept for real estate investors. It is simply the total cash they get from a deal every year as a percentage of the total cash invested; how much cash they put in their pocket compared to how much was invested.

As far back as 2016 Keithahn has been promoting himself as the medical school's chief financial officer; I wonder who is paying that salary? I do know that PFA will be paying Keithahn to manage the operation of the medical school and paying him again to manage the operation of the medical school housing facility. The one thing we can know for sure, Keithahn will be reaping extraordi-

nary economic benefit from this deal; the rest of the citizens of Gaylord and Sibley County have no such guarantee. Granted the ability to succeed is the foundation of the American dream and by all means, attempt to do so with your own private money. But when you enter the public square and take public taxpayer dollars you jeopardize the American dream for every average, hardworking taxpayer with limited resources living on crumbling streets!

The Sibley County Commissioners on June 12 collectively agreed they support this TIF project, even though they stated that, "...there is no guarantee the school is coming anyway." The Sibley East School Board on June 18 collectively agreed they will make no collective comment on the TIF project, though they stated, "...there is so much unknown...not enough information to make an educated guess on the economic impact."

Taxpayers of Sibley County, it's time to remind the elected officials of this county and cities who put them in office. Come to the public hearing and have your voice be counted and then go to the polls in November and have your voice counted again with your vote.

Administrator talks about budget process

Every year, Sibley County completes an annual budgeting process. The budget is one of the most important documents that the county prepares because it identifies the services to be provided and how they are to be financed. Sibley County's budget process is ongoing and year round. For example, the process started earlier in the year with a review and subsequent adoption of the capital improvement plan and has now moved into development of our overall line item budget. A line-item budget shows the departmental expenses grouped according to the items that will be purchased, with one item or group of items on each line (e.g. salaries and wages, contract services, supplies and equipment). The County has three main funds that compromise our line item budget, General, Road & Bridge, and Public Health & Human Services and several minor funds such as capital projects and debt services. At

the end of the process, the overall tax levy or the amount of taxes to be collected will be set by the County Board.

A schedule was developed as the guide for budget preparation. The first step in the process is for each department to take a look at past and current spending and revenue levels and develop a first draft budget. Next, work sessions are held with the Board along with departmental meetings that are ongoing with the County Administrator. This work will take place from June to September. The preliminary budget and levy must be set no later than September 30, 2018.

• Sept. 25 Board Meeting - Set the 2019 Preliminary Levy and Budget

• October, November and December - continue to update and review budgets as needed

• Dec. 6 – Budget Public Hearing Meeting

• Dec. 11 or Dec. 26 Board Meeting – Adopt 2019 Budget and Levy

All of the work sessions are open public meetings and the times for each will be posted on that date's county board agenda.

MNA delegation rallies support in D.C. for newsprint tariff relief

Minnesota Newspaper Association (MNA) members were in Washington, D.C., last week urging lawmakers to intervene in a recent U.S. Department of Commerce decision they believe poses a serious threat to the future of not only newspapers across the state and nation, but to freedom of the press itself.

“This tariff could well have a devastating trickle-down effect on the state and national economy,” said MNA Vice President Karin Ramige, publisher of The McLeod County Chronicle and Arlington Enterprise.

Minnesota is served by around 320 newspapers, 238 of which have a circulation of less than 5,000 and 181 of which have a circulation of less than 2,500. MNA Executive Director Lisa Hills said some smaller community newspapers, which are already stressed by a decline in retail advertising and a soft ag economy, may have to make a tough choice in light of escalating newsprint costs — fight on with little hope of remaining financially viable, or simply cease to exist like so many other small businesses in rural Minnesota.

What’s especially frustrating, said MNA President Mike Dalton, publisher of the Cannon Falls Beacon, is how the tariff came to be in the first place — as a result of a petition filed by a single paper mill in Washington state owned by a New York private equity firm. “On the basis of that one petition submitted by that one paper mill, in the absence of support by any other U.S. newsprint mill or associated trade group and without any opportunity for public comment or input, the U.S. Department of Commerce slapped these tariffs on Canadian newsprint — the only source of newsprint for many of America’s newspapers — and disrupted an entire industry,” he said. “This lone paper mill employs about 500 people. Its petition and subsequent action by the U.S. government have put literally hundreds of thousands of jobs in the newspaper, publishing and printing industries at risk. That just doesn’t seem right.”

Many lawmakers in Congress agree. Legislation has been introduced in the U.S. House and Senate that would suspend tariffs on Canadian newsprint and require the U.S. Department of Commerce to study the economic health of the printing and publishing industries and the potential economic effect a permanent tariff would have.

The Minnesota newspaper delegation traveled to Washington, D.C., last week to rally congressional support for the bill and ask lawmakers to testify at or submit comments in advance of a July 17 International Trade Commission hearing.

Other members of Minnesota’s congressional delegation are currently weighing the merits of intervening in the case. The U.S. Department of Commerce will issue a final determination in the case on Aug. 2. The ITC’s final determination is expected in mid-September. U.S. Sen. Amy Klobuchar of Minnesota has agreed to co-sponsor the legislation in the Senate. “We are grateful to Sen. Klobuchar for stepping forward and showing leadership by signing on as a cosponsor of this bill,” said Randy Lebedoff, general counsel for the Star Tribune of Minneapolis.

Dalton encourages newspaper publishers, editors and other staffers — along with others involved in the printing and publishing industries and even community members who see value in their local newspapers — to contact their representatives in Congress and urge them to intervene, by signing on as a cosponsor of the Protecting Rational Incentives in Newsprint Trade Act of 2018 (H.R. 6031/S. 2385) and testifying at the July 17 ITC hearing or submitting comments ahead of time.

“Members of Congress from both sides of the aisle understand how essential a free press is to the well-being of our country and see how this unwanted tariff is posing a direct threat to that,” Dalton said. “This is truly a bipartisan issue and we see that represented in those members of Congress who have either signed on as cosponsors of the bill or who have agreed to testify or submit comments to the ITC. We applaud them for not only standing up for small businesses, jobs and economic prosperity, but also for standing up for the First Amendment, the U.S. Constitution and the future well-being of the country we all love.”

FSA Matters

USDA's Farm Service Agency recently released signup information for the Tree Assistance Program, a nationwide program that provides orchardists and nursery tree growers with cost share assistance to replant eligible trees, bushes, and vines following a natural disaster.

The Bipartisan Budget Act of 2018 prescribed several changes to the program, including the removal of the \$125,000 per person and legal

entity payment limitation. The notice outlined when producers should file applications for any recent losses, given the changes to the program.

Eligible producers should file for TAP assistance by the later of these two dates:

- 90 days of the disaster or when damages from the disaster are noticed; or
- 60 days after the regulation is published on the Federal Register later this summer.

The following producers can file applications:

- Producers who did not

previously apply for TAP for 2017 or 2018 losses; and

- Producers who had applied and received an adverse determination that their 2017 or 2018 TAP application was filed late.

Additionally, producers with 2017 losses can also file an application or revise an original application because of the changes made through the Act. For more information on TAP, producers should contact their local USDA service center.

U of M Small Grain Summer Plot Tours set

The University of Minnesota Extension is offering four on-farm Small Grain Summer Plot Tours in Central and Southern Minnesota in June and July to address small grain production issues, variety performance, and insect and disease pests.

These programs are designed to provide farmers and crop consultants the tools needed to make small grains a successful crop in their operation. This includes information on production agronomics, variety selection, disease identification, fungicide use, fertility, and economics. These programs are interactive and discussion based, featuring a tour of current re-

search plots and discussion of on-farm experiences.

The first tour will be held at the Ron Pomiji/Ruth Hoef farm, 20676 340th Street, Le Center, from noon to 3 p.m. Thursday, June 28. Lunch will be served prior to the plot tour.
