## Sibley East School Board hears update on hallways

At their regular Sibley CEast School Board meeting RA Morton provided School Board members with an update on hallway 1060 and the hallway 1020 ramp correc-

Wilson reported that Evenson Concrete Systems and their sub-contractor CCU came back and ground hallway 1060 which was reviewed by Superintendent Jim Amsden and Wilson. They found that it was now compliant and accepted it.

Euerle reported that unfortunately Evenson and CCU mobilized off-site before finishing the hallway 1020 ramp. Euerle said he spoke with Evenson during the day and that they were meeting with another grinding company who may be able to grind that hallway if CCU is unable to return and finish it. Euerle assured School Board members that Evenson would bring in someone to finish the hallway 1020 ramp before school be-

School Board member Avery Grochow praised the workers from CCU. He stated that the "young men did an excellent job in 1060." He stated that the "exposed stuff looks nice" and that it was like night and day difference.

Euerle speculated that CCU

may have had another job to get done or maybe they were concerned that they would not be able to get the same results on Monday night, July 15, in 1020. > had anticipated. Euerle told School Board members that they still had the option to replace the concrete in 1020 if it does not turn out like they expected, but assured School Board members that they would get it done before school starts.

#### **Accepts Quotes**

School Board members accepted quotes from Gaylord Sanitation for refuse collection at both the Arlington and Gaylord sites. Gaylord Sanitation was the only quote for both sites, but Business Manager Janna Tessmer stated that Gaylord Sanitation has kept their quotes at the same amount for the past several

#### Contract

The School Board reviewed quotes for gasoline and diesel fuel from three companies, United Farmers Coop (UFC), Central Farm Supply (CFS), and On Time Petroleum.

Amsden told School Board members that the three quotes were not the same because CFS provided a quote for a contracted amount that would remain the same the whole year, while UFC and On Time provided spot quotes. Spot quotes are based on the price of fuel at the time of the quote but will vary throughout the

Amsden stated that CFS out of Mankato does a lot of 4.0 tracts and would like to change the diesel tank at the Arlington fairgrounds to gasoline. Amsden stated that Sibley East will now have nine buses that run on gasoline and only four on diesel fuel.

School Board member Laura Reid said she would like to support local businesses, but that she would prefer to contract. School Board member Sarah Ziegler looked up the price of diesel fuel and found the market to be very volatile and felt it would be better to contract. Grochow stated that he would prefer to keep gas and diesel from the same company instead of going with one company for

gasoline and one for diesel. Amsden stated that next year, when getting bids, he will request that all companies follow the same process and either all do spot quotes or all quote contracts.

## Jim Heiland resigns from the Arlington City Council

The Arlington City Council, during its regular meeting on Monday night, July 15, unanimously approved a motion to accept a letter of resignation from City Council member Jim Heiland.

His resignation will be effective after the regular meeting on Monday night, Aug.

City Council members Michelle Battcher, Adam Cowell, Tom Hatlestad, Jim Heiland and James Jaszewski all voted in support of the mo-

"It's been a very difficult process," said Heiland, who has purchased a house in Bloomington. "As much as I love Arlington and its people, I find it necessary to move closer to the VA Hospital in Minneapolis.'

Heiland continued, "It's been an experience of a lifetime and I really enjoyed working with council members, city administrators, city attorney, city staff, our police chief and officers, fire chief and all the firefighters. I can't forget the EMTs and first responders. The city maintenance has come a long way and we are very fortunate to have them."

Heiland added, "And I can't forget the residents of Arlington who had the confidence to elect me to a second term. I'm not leaving forever yet, plan to be around while I can.'

Heiland was first elected to a four-year term on the City Council during the fall of

2014. He was re-elected to another four-term on the City Council last term. Once his resignation becomes effective, there will be a little less than 3 1/2 years left on his term.

#### Filling Vacancy

The City Council, later in the meeting, held discussion on the process to fill the vacancy created by the resignation of Heiland.

City Attorney Ross Arneson basically said the City Council has two options.

First, the City Council can look back at the last election and select the next highest vote getter.

Second, the City Council can advertise for the open position and have interested residents submit applications for appointment.

Hatlestad, Battcher and Jaszewski all agreed that the application process is the best way to proceed.

Cowell added that the entire City Council should interview the candidates.

The City Council used the application process when John Griep resigned during September of 2009 and Richard "Dick" Nieland resigned during November of

Interested people who would like to be considered as a candidate are encouraged to submit a letter of interest on why they would like to serve on the Arlington City Council along with a resume to the City Administrator, 204 Shamrock Drive, Arlington, MN 55307. The deadline is 4 p.m. Wednesday, July 31.

The City Council has tentatively scheduled interviews for the vacant position for the late afternoon/evening of Monday, Aug. 5.

#### WAC & SAC

The City Council unanimously approved a motion to approve a request from Leah Schrupp to consider WAC & SAC waiver for her purchase of a lot on High Island Circle.

The Arlington Economic Development Authority (EDA) established this incentive last year in an effort to jumpstart housing in Arling-

The EDA initially had enough funds to cover three WAC & SAC waivers which were granted last year. The authorization has since been transferred to the City Council who considers each request on a case by case basis.

## Residents upset over sewage in basements during recent storm

The Arlington City Council, during its regular meeting on Monday night, July 15, heard from residents upset over sewage in their basements during a recent storm.

Mike Scharping, who owns NAPA, reported that his business has had raw sewage come up in the basement for the third time in the last couple years. The flooding, he said, damages the inventory which is stored in his base-

Scharping said he paid his assessment for the 2015 Street & Utility Improvement Project and the flooding "has gotten worse" since the completion of the project.

Scharping added that the flooding is not a sump pump issue. The flooding starts shortly after a heavy rain be-

City Council member Adam Cowell said his basement also flooded just about one block away.

Bob Thomes also shared his frustration. Thomes has owned his house along the 200 block of East Baker Street for 30 years, but experienced no flooding during the first 25 years. Water and sewage has come up through the floor drains and flooded his basement twice in the last five years. Thomes said someone has to be held responsible for this flooding issue. The issue, he said, has to be resolved.

Thomes also complained that the dumpsters arrived too late in the parking lot at the Community Center. He added that residents who experience flooding issues need dumpsters immediately after they begin the clean up process.

City Council member Tom Hatlestad stressed that the city needs to find the problem and resolve the issue.

City Administrator Pat Melvin reported that city officials will continue to meet with officials from People Service, Bolton & Menk and other entities to identify the

## **Business would like to purchase 22-acre lot in Arlington**

**Editor** Hemp Heaven LLC, an established agricultural business comprised of fourth generation farmers in Wausau, Wis., has proposed to purchase an approximate 22-acre lot from the City of Arlington based on the Commercial Building and Lots Policy. The property is located south of Northland

Hemp Heaven, according to owner Derrick Bushman,

wishes to expand its capabilities into the industrial processing and extraction of hemp for CBD. Bushman is an owner and current board member of Northland Drying LLC.

The current production of hemp not only in Hemp Heaven, but other regional farms will require technology and expertise currently utilized at the Northland Drying facility. In addition, the existing infrastructure and utilities that are currently underutilized at the

Northland Drying facility are a good fit for meeting the timelines required for this planned development, according to Bushman.

The current proposal is for the construction and operation for a combination of the following:

1. Establishment of large year round greenhouse opera-

2. Establishment of cloning and hybridization laboratories. 3. Installation of large scale extraction and refining equip-

4. Use of rail for both loading and unloading regional (or national) biomass

5. Establishment of cultivar and planting test plots for industry analysis

Hemp Heaven currently employs 25 full-time equivalent jobs just to perform items one and two from the previous list. In a joint venture between Northland Drying and Hemp Heaven, the anticipated em-

ployee growth would likely exceed 30 full-time equivalent jobs within the first calendar year. These jobs would be a combination of skilled and unskilled labor along with management, office, engineering and scientific researchers. A portion of the labor would be seasonal. However, the intent would be for 24/7/365 operation of grow, extraction and scientific process. The lowest paying position would be \$15 per hour while the highest

paying position would be a salary of \$70,000 a year.

Bushman made his presentation to the Arlington EDA during a recent meeting

After the presentation, the EDA made a recommendation to the Arlington City Council to approve the proposal.

The City Council is expected to act upon the recommendation at its next regular meeting at 6:30 p.m. Monday, Aug.

and fell onto the street. Arlington Maintenance Supervisor Kirby Weckworth used the city payloader to clear the branch from the road.

## Fire breaks out at Altona Colony near Henderson

A fire broke out in the attic of the utility building at Altona Colony, located about three miles outside of Henderson, at about 8 p.m. Monday, July 15, according to an article in the Henderson Inde-

According to Mark Wollman, secretary-treasurer at Altona Colony, the blaze originated in the muffler in the

The community, which consists of approximately 120 Hutterites, originally tried to put the fire out using their own tanker while they were waiting for emergency personnel to arrive.

The Henderson Fire Department responded to the scene first. The Arlington Fire Department arrived about 10

The fire quickly spread, and by the time the fire was extinguished, the roof had collapsed.

Wollman reported that nobody was in the building at the time of the blaze, although they did attempt to remove some of the materials in the building before the decision was made to clear everyone

out, Wollman said.

The building was used to house the colony's phone switch, water softner and electrical generator and supplies, Wollman said.

With the destruction of the building, the entire colony is without power, Wollman said, and they have to wait for the utility company to come out.

#### MnDOT shares good and bad news on Highway 14/15 New Ulm project

Work continues on the New Ulm Gateway (Highway 14/15) project that is in its second year, but construction crews struggle on the new river bridge as the Minnesota River remains high enough to prevent work in the river. However, the new interchange at Highway 14/15 is progressing well and will likely be completed ahead of schedule.

Construction on the Minnesota River Bridge experienced delays in 2018 due to high river levels and in 2019 progress halted in March. The access road is presently about five feet under water and the barge cannot be secured at current river levels.

"We need the Minnesota River to fall to 795 feet to resume bridge work," according to Todd Kjolstad, MnDOT construction supervisor. "We don't see that level in the current forecast, but hope it is before the end of July so that we can complete the bridge this

The early completion of the Highway 14/15 interchange, which could be in mid to late August, will alleviate motorists using the current lengthy detour. Much of the concrete work is done, the bridge is near completion and asphalt paving should take place soon.

For now, traffic continues to be detoured to Nicollet County Road 5 (Fort Road) and Nicollet County Road 12 and

Nicollet County Road 21 between Nicollet and Courtland.

The Highway 14/15 New Ulm Gateway project addresses intersection safety, aging bridges, poor pavement conditions and occasional road flooding around New Ulm. Construction began in 2017, with the majority of the work and detours taking place in 2018 and 2019.



#### **Educators in Gaylord are getting S.M.A.R.T.**

Early childhood educators from southern Minnesota are quickly enrolling in a unique, interactive three-day workshop called S.M.A.R.T. These fun and interactive workshops will have participants learning about a child's brain development, and how physical movement and activities stimulate and enhance learning in the classroom.

The workshop, designed for educators working with K-3 students, will be held at the Sibley East Elementary School in Gaylord from Tuesday, July 23 through Thursday, July 25.

S.M.A.R.T. - Stimulating

Maturity through Accelerated Readiness Training - is an innovative, school readiness program that inspires educators to teach with a developmental perspective. S.M.A.R.T. is currently used in approximately 300 pre-K, kindergarten and elementary classrooms throughout Minnesota, as well as 12 other states across the nation. The program was created by the Minnesota Learning Resource Center (MLRC), a nationally recognized teachertraining institute affiliated with a Minnesota-based nonprofit organization called A Chance To Grow, which offers comprehensive braincentered programs and serv-

The workshop is funded by grants from the Southern Minnesota Initiative Foundation (SMIF) and the Otto Bremer Foundation specifically for early childhood education sites within Minnesota's southern region.

"The key to the S.M.A.R.T. program's continued success in our region is two-fold," says Rae Jean Hansen, VP of early childhood initiatives at SMIF. "Schools using the program see immediate benefits to the children in their classrooms, and educators benefit from the program because it offers them on-going training and mentoring."

According to MLRC data, classrooms that participate in S.M.A.R.T. have higher attention and participation levels, are more motivated to learn and show higher academic achievement. The underlying factor is specific brain stimulation produced by purposeful movements, which leads to the development of a child's motor skills that ultimately fosters learning.

"Participants will walk away from the experience with a new perspective on teaching. They will understand S.M.A.R.T. is not what they teach but HOW they teach children." said Cheryl Smythe, Director of the MLRC at A Chance To Grow.

## People depend on insulin to survive

To The Editor,

There was a lot of conversation in St. Paul this year centered on access to insulin for individuals with diabetes. Sadly, last year, a young man from Minnesota passed away in 2017 when he was unable to afford insulin.

Simply put, diabetics should not have to worry about where their next dose of insulin is coming from. These folks depend on insulin to sur-

Just this session, we passed a few bills to improve awareness and access to insulin for low-income individuals.

The special session Health and Human Services (HHS) Omnibus bill, included a provision to improve consumer knowledge of and access to patient assistance programs operated by drug manufacturers.

Many drug manufacturers offer patient assistance programs that provide financial assistance or free medications to low-income individuals. Today, there exists numerous resources online for consumers to see if their medications have assistance programs. Starting August 1, Minnesota will begin offering its own resource for individuals.

The Board of Pharmacy will be tasked with operating the program on its website. Through this portal, a patient will be able to find information about:

1. Patient assistance programs of-

fered by drug manufacturers, including information on how to access the programs

2. The prescription drug assistance program established by the Minnesota Board of Aging

3. Websites through which individuals can access information concerning eligibility for and enrollment in Medicare, medical assistance, MinnesotaCare, and other governmentfunded programs that help pay for the cost of health care

4. Availability of providers that are authorized to participate in the 340B Drug Pricing Program

5. Having a discussion with the pharmacist or the consumer's health care provider about alternatives to a prescribed drug, including a lower cost or generic drug if the drug prescribed is too costly for the con-

6. Any other resource that the Board deems useful to individuals who are attempting to purchase prescription drugs at lower costs

This will be a great resource for any individual who is looking for a way to reduce the cost of their health care. It will be especially helpful for those who must take expensive prescription drugs, including insulin.

Additionally, the three major insulin manufacturers each offer their own program to help low-income patients afford medication.

This is just the tip of the iceberg for patient assistance programs. When the Board of Pharmacy has its resource available, it will be a great benefit for patients who struggle to afford their medication.

I am hopeful that we will be able to take additional steps next session to address this problem. Until then please be sure to take advantage of the resources listed above if you need assistance. You can also reach out to my office if you ever have a question regarding this issue or any other matter related to state govern-

## Boys will be girls and Collin Peterson endorses it

If you have been watching the news as of late, you have most likely heard that some politicians in Washington want to allow boys who identify themselves as girls to use women's bathrooms and showers. Under H.R. 5, any woman claiming to be a man or any man who thinks he's a woman is granted the same legal rights that these civil rights laws confer upon racial minorities. Sexual minorities could, in fact, be granted protected class status and given preference in hiring under affirmative action. Businesses would be required to hire defined percentages of sexual and gender minorities (as well as pay

for gender reassignment surgery).

The so-called Equality Act is a direct assault by Democrats on religious liberty and imposes a perverted sexual ideology on the nation. It would make it easier for sexual predators to share bathrooms with little girls, punish doctors for treating gender-confused children, and take away the rights of parents to decide what is best for their children. For those parents who have daughters on sports teams, H.R. 5 would allow transgenders to compete with girls and put them at a physical disadvantage (an issue that has caused headlines in newspapers and digital articles across the nation), while setting new records in the process. Do you support this law? Then keep voting for Collin Peterson and left-leaning politicians. They won't do anything to stop it.

## Public Health's aim is to reach all parents with new babies in county

Are you a new mom who has just delivered a new baby? Do you live in Sibley County? Whether you've just had your first baby or your third, fourth or fifth, Public Health would love to

meet you and your baby! It is the goal of Sibley County Public Health to contact every parent in our county who has recently had a baby. This contact is called a "Universal Contact". A Public Health Nurse will attempt to call you after you return home from the hospital. The phone visit offers an opportunity to set up an appointment to visit you and your new baby. This visit is free, confidential and in the convenience of your own home.

When the nurse comes to your home, your baby will be weighed, and time will be spent with you to educate and answer questions about your newborn and your own recovery. Newborn education could include eating/sleeping patterns, baby care, growth and development, safety, and immunizations and well child care. Information for mom could include postpartum recovery and care, signs and symptoms of postpartum depression, rest and activity, nutrition, breastfeeding or bottle-feeding questions, and

connection to community resources. Our nurses have extensive training in breastfeed-

Sibley County Public Health learns of births to residents primarily through two ways. Many area hospitals send delivery/discharge referrals to Public Health, so moms can be contacted. The Minnesota Department of Health notifies local public health agencies through a weekly Vital Statistic report (birth records). Notifications that are received through Vital Statistic reports do not include phone numbers, so in those instances, letters are mailed to moms. Referrals from hospitals almost always include a phone number, which makes contacting moms much easier.

Sibley County Public Health has been fortunate to receive grants that help purchase items for a gift bag. Gift bag items may include a blanket to promote "tummy time", baby toothbrush, outlet plugs, books and a "Baby's First Year" calendar. A resource packet is also given and includes information on local and state programs (i.e.; Follow Along and Imagination Library), growth and development, postpartum recovery, immunizations and safe-

Here's what some Sibley County moms have said about their new baby visits:

~ "She was so kind and helpful! I learned a lot about growth and development of children, and what will help my child. Thank you for coming into my home and giving me all the different information new moms and/or parents need!"

~ "It's nice to have a nurse visit that isn't rushed. I enjoy having the time to ask questions. I also really enjoy being able to have my baby weighed; as a breastfeeding mom, it's great to know my baby is gaining weight."

~ "I wasn't going to take a visit at first, but then my friends said I should because the visits are fun and so helpful. They were right, and she came to me, so I didn't have to bundle up my baby and go somewhere during this really cold weather!"

~ "The support at the beginning helped tremendously. Made me feel like my struggles were normal."



By Dan Mahoney, CED Sibley County FSA **Disaster Assistance: USDA Emergency Disaster Designation and** 

**Declarations Process** Sibley County residents are accustomed to dealing with difficult weather events. This year residents have experienced heavy accumulating snow falls leading to structure collapses. There has been building and crop damage due to strong winds and hail. People have endured continued flooding that has affected buildings, pastures, and crops. Most recently there has been tornado damage in the county as well. Severe weather events and natural disasters have always been a challenge for those who make their living through farming. Unfortunately, agriculture related disasters are quite common. The USDA Farm Service Administration administers four different types of disaster designations. The designation of counties as disaster areas makes emergency (EM) loans available to producers affected by the disaster. Disaster designations also play a role in determining eligibility for other disaster assistance programs administered by USDA.

Keep in mind that your FSA office tracks natural disasters that affect our farmers. If you suffer losses due to hail, wind, flood, or drought, please contact your local USDA Service Center. Depending on the type of loss, and impact to the county, disaster assistance may be available. Any pictures or information that you provide will also be helpful in telling the story of the disas-

The first type of disaster designation is a USDA Secretarial disaster designation. This type must be requested of the Secretary of Agriculture by a governor or the governor's authorized representative, or by an Indian Tribal Council leader. The Secretarial disaster designation is the most widely used and this process is the most complicated of the four.

The second type of disaster designation administered through the Farm Service agency is the Presidential major disaster and Presidential emergency Declaration. Presidential major disaster

declarations, which must be requested by a governor to the President, are administered through the Federal Emergency Management Agency (FEMA). A Presidential major disaster declaration can be made within days or hours of the initial request. FEMA immediately notifies FSA of the primary counties named in a Presidential declaration.

The third type, FSA Administrator's Physical Loss Notification (APLN) is for physical losses only. An example would be the loss or destruction of a building destroyed by a tornado. Livestock related losses are considered physical losses. An APLN is requested of FSA's Administrator by an FSA State Executive Director. Local USDA staff assist in collecting information regarding damage and scope of a weather event and provide such information to the State Executive Director.

The last type of disaster designation administered by FSA is a Quarantine designation by the Secretary under the Plant Protect Act or animal quarantine laws. A quarantine designation is requested of the FSA Deputy Administrator for Farm Programs by an FSA SED. A quarantine designation authorizes EM loans for production and physical losses resulting from a quarantine.

All four types of designations, Secretarial disaster designations, Presidential disaster declarations, APLNs, and quarantine designations immediately trigger the availability of low-interest FSA EM loans to eligible producers in all primary and contiguous counties.

Due to the role FSA plays in administering disaster designations and assistance programs Sibley FSA encourages producers to notify the local office of damage to buildings, crops, and other agricultural infrastructure. If the damage documented meets qualifications or reaches a predetermined level, our County Emergency Board will submit documentation and ask for federal disaster assistance. ## **Process underway to upgrade** lighting at Arlington Museum

The Arlington Historical the ceiling providing space for application, the Historical So-Society has begun the process of upgrading the Arlington Museum lighting to meet museum standards, which includes the use of energy efficient lighting.

The Historical Society received a small grant of \$7,693 from the Minnesota Heritage Fund to cover the cost of the professional lighting designer, Richard Rummel, in 2017. His design was completed and approved in 2018. Bids for the cost of the remodeling project were solicited, both for the actual cost of museum remodeling and the costs of the lighting, and the Historical Society approved a plan to do the remodeling of the museum over a two-year period.

The first step was to raise

taller exhibits and allow for lighting focused on the exhibits. Travis Tuchtenhagen Contruction, Arlington, has extended the walls and installed the grid work for the new ceiling.

In June 2019, the Historical Society applied for a large grant of \$22,000 from the Heritage Fund to cover the actual cost of the lighting. The grant application showed this as a two-year project and that the first part has been completed and needs funds to complete the lighting upgrade.

The total cost of the project is a little over \$38,400 which includes repainting the museum and installing new carpeting on the floor. In addition to the large Heritage Fund Grant


