Races develop as filing period ends

A number of races developed as the filing period for local elected offices closed at 5 p.m. Tuesday, Aug. 16.

The General Election will be held on Tuesday, Nov. 8.

Arlington

In the City of Arlington, incumbents Jaszewski and Jennifer Nuesse and candidate Adam Cowell all filed for the three open seats on the Arlington City Council. Incumbent Galen Wills did not file for re-election.

The terms of Jaszewski, Nuesse and Wills will all expire at the end of this year.

The terms for these three open positions are for four years each.

Green Isle

There will be two races in the City of Green Isle. Joe Kreger and Scott Beebe both filed for the open mayor position. Incumbent Mayor Dale

ZumBerge did not file for

re-election.

Incumbents Brian Oelfke and Mark Wentzlaff and candidates Jessica Andreas, Diane Brown and John Huston have filed for the three open seats on the Green Isle City Council.

The terms of ZumBerge, Wentzlaff and Oelfke will expire at the end of this year.

The terms for these three positions are for four years each.

Sibley East

Seven candidates have now filed for the three open positions on the Sibley East School Board.

The seven candidates are incumbents Brian Brandt, Nathan Kranz and Missy Weber and challengers Michael Christeson, Rae Anderson Grimm, Jonathan Hazelwood and Avery Grochow.

The terms of Brandt, Kranz and Weber will all expire at the end of the year.

The terms for these three open positions are for four years each.

their signed diploma that day. School Board member hammer had thought the process through for next year. She also stated that she had

Council votes 3-2 to consider no alcohol in the local parks

The Arlington City Council, during a regular meeting on Monday night, Aug. 15, voted 3-2 and approved a motion to leave Ordinance 295 intact which prohibits alcohol in local parks, but modify section six to allow the City Council to grant permission on a case by case basis.

City Council members Michelle Battcher, Jennifer Nuesse and Galen Wills all voted in favor of the motion.

City Council members Jim Heiland and James Jaszewski voted against the motion.

Heiland and Jaszewski believed a resident or small group should be able to have alcohol in Four Seasons Park or Arlington Sportsmen's Park without city permission.

The vote, however, was not a final move on the matter. The City Council, during its next regular meeting on Tuesday night, Sept. 6, will now consider the new language in first reading of an amended ordinance. Unless there are major changes, the City Council will hold the second reading of the amended ordinance during its regular meeting on Monday night, Sept.

Under the new language in

section six, the City Council would be able to make exceptions for special events sponsored by community service organizations, a city celebration, class reunion or family reunion.

In addition, the City Council would like to include signage about no alcohol since there is signage about no tobacco in all parks.

The discussion and vote on the issue was a complete turnaround compared to a healthy discussion held at the last regular meeting in early August. The City Council, during that regular meeting, discussed a possible move to allow alcohol in Four Seasons Park and Arlington Sportsmen's Park under some type of an application

In other business, City Administrator Liza Donabauer announced that the City Offices will be closed for the Labor Day holiday on Monday, Sept. 5. The Arlington City Council will hold its next regular meeting at 6:30

Restructuring Committee presents an

update to the County Board at meeting

Correspondent On Thursday, Aug. 11, the Sibley County Restructuring Committee updated the County Board on the proposed new Sibley County organizational structure.

The restructuring committee consists of eight members. They are Auditor Marilee Peterson: Assessor Laura Hacker; Public Works Director Tim Becker; Patty Buerkle, Public Health and Human Services; Rita Severin, Recorder's Office; Diana Karau, Environmental Services; County Commissioner Joy Cohrs; and County Commissioner Bobbie Hard-

The goal of restructuring is to "design an organizational structure that will provide quality and efficient services to the public." The characteristics of that goal include

providing better service, onestop shopping, cross training, and efficiency of costs and services by reducing the number of departments and department heads.

The committee members stated that there are too many one and two-person departments, lack of interaction between departments, too much traveling between departments, and duplication of services. As part of their research on restructuring, the committee members asked departments to complete interaction forms, asked about department duties, and asked about inefficiencies. Four drafts of the proposed organizational restructuring were posted on the county's internet for employees to view.

The committee proposed five moves. Building Maintenance would be moved under Administration, Ab-

Property Records, Veteran Services to Public Health and Human Services, Ditch (Finance) moved to Property Tax and Public Service, and Ditch (Maintenance and Re-

pair) moved to Public Works. County commissioners, department heads, and employees will have the chance to provide comments and return surveys about the proposed changes to the restructuring committee. The committee will review the comments and surveys on Friday, Sept. 9 and design the next draft. The final draft will then be sent to the County Board for approval. County Administrator Roxy Traxler stated that she would like to have the final draft by November and have the restructure approved and adopted by the end of the

County Commissioner Jim

ice organizations are against putting Veterans Services with Public Health and Human Services because of the stigma associated with going to public services.

Department heads questioned what would happen to a department head when departments are combined. They also questioned if job descriptions would be different. The department heads questioned if the committee researched the cost to redo all of the offices and if it was a cost savings to the county. The restructuring committee did not answer any of the questions at the meeting. Traxler stated that an additional work group will be created to study the organizational chart and how the county can best utilize existing spaces.

County Board discusses adding a public comment section to agenda

Sibley County Board members, during their regular meeting on Tuesday morning, Aug. 9, discussed updating the board policy to add a public comment section to the County Board agendas.

County Commissioner Bobbie Harder stated that this was part of having open communications, "allowing the public to come to the Board with questions and concerns."

She also felt that it "provides for a way for the Board to set the record straight."

Harder and Sibley County Administrator Roxy Traxler provided some examples from other counties and suggested adding time limits and limiting the number of times people could come to a County Board meeting. Harder would like to see it added to the end of the agendas.

Traxler stated that the County Board could require

visitors to give advance notice, sign-in on the day of the Board meetings or just have a time that is open to the public. The County Board will not take any action on items that are discussed during the public comment section of the agenda. Traxler also stated that there would be no personnel issues addressed, no attacking Board members, and no addressing others in

the audience. Harder felt that this was a

"continued effort to be more open, more transparent."

County Commissioner Bill Pinske questioned if the public comments could be limited to Sibley County residents and taxpayers. He was concerned that salespeople would want to come before the County Board.

County Attorney David Schauer said that it would have to be "open to anyone to talk." Schauer stated that Carver County has a public

comment section, but they limit comments to two minutes per person and a maximum of 10 minutes. Pinske was also concerned about people coming in to argue the same point every month.

It was the consensus of the County Board to have Traxler write a draft of a public comment policy for the next Board meeting on Tuesday, Aug. 23. The draft policy should include setting a maximum of two minutes per per-

son to talk and 10 minutes total allowed for comments. The policy should limit individuals' comments at meetings to one time per month. The policy should also include having a sign-in sheet for those who want to make a comment, so the Board has a record of who spoke and what they spoke about.

Highway 169 Mankato to St. Peter partial opening set for late August

Weather permitting, the detour for Highway 169 between Mankato and St. Peter could be removed by Saturday, Aug. 27. When reopened Highway 169 will carry one lane of traffic each way with a 55 miles per hour speed limit and further reduced speeds where work is taking place.

Motorists are advised to use caution as the inside lanes will be closed for construction of the concrete intersection crossings, concrete median, left turn lanes, high tension guardrail and raised concrete barrier. Workers will be present and construction vehicles will be entering and exiting the open lanes. The Minnesota Department of Transportation (MnDOT) has retained extra law enforcement and advises motorists to refrain from gawking to keep traffic moving safely.

Traffic control on Highway 22 will remain as is until traffic normalizes.

Traffic control on the detour (Highway 99, County Road 13) will have the temporary signals deactivated and previous conditions restored:

• Nicollet County Road 13 (Lookout Drive). Howard Drive intersection - returned

• Highway 99/County Road 333 (Shepard Road) intersection - returned to two-way

Not all Highway 169 intersections open in late August. Only the following are targeted to open:

• Hiniker Saw Mill

- Old River Bluff Road (south end)
- 492nd Street • 381st Street
- 367th Avenue
- Freeman Drive

 Washington Avenue Seven Mile County Park remains closed until the completion of the flood mitigation project, which is antici-

pated in mid-October. The project includes raising the grade in four floodprone areas (Hiniker Mill, 7mile Creek, Old River Road, and State Hospital) to raise the road above the 100 year flood, six miles of resurfacing for a smoother road and a median barrier to prevent headon crashes. The \$30 million project received a \$9.8 million grant from the EDA (Economic Development Administration).



Commissioner listens to questions and concerns

Security of our facilities is important. Several months ago, the camera system in the jail was updated. These updates have allowed greater visibility both inside and outside of the jail. More cameras will be installed in the courthouse and annex. The county was able to obtain a cost sharing grant to expand our camera system. A total of 14 new cameras are in the process of being installed. Nine of the cameras will be located on the third floor, two on the first floor, and three covering the entrance/exits of the building. The total cost of these cameras is approximately \$26,000. Additional security measures, such as impact resistant glass, are being researched.

This glass would cover the large window openings in areas such as probation, court administration, and treasurer/auditor.

As mentioned in a previous article, I had a booth at the Sibley County Fair. The purpose is to network and to hear about the issues which affect all of us. There were many nice compliments about the fair, the recent improvements, the entertainment, and free admission was a plus.

A variety of topics were voiced by residents. The first issue pertained to the county's involvement in the proposed medical school in Gaylord. The concern was whether or not the county was putting dollars or allowing tax breaks for the school. The only involvement the county has had

at this point was in April. A letter of support was submitted for the school. To my knowledge no one has approached the county for any

additional support. Questions were raised as to whether or not the courthouse is "falling down." Over the years, routine maintenance and updates have been lacking. Using a bucket under a leak for nearly 10 years is not a fix. Having one boiler system for the entire building is not wise. It has come to a point where numerous items need attention and the cost for some of the repairs is expensive. For example to replace or repair windows in the courthouse and

annex may be over \$500,000. Since the court house is a historical landmark, there are certain items we are required to do. Reducing the window size isn't one of them. The total cost of the needed repairs (windows, HVAC, insulation, coal chute, etc.) will not be known until bids are obtained. I am not in favor of bonding, as this is paying interest on items which should have been addressed years ago. In light of this situation, bonding may be our only option to remedy these issues.

Numerous questions were voiced regarding the restructuring of county departments and the proposed draft. Everyone agreed it would be a wise decision to reduce the number of departments which have one or two people. It increases accountability. As a member of the committee I was able to share the process and how the draft came about. It is important to present a draft and obtain feedback from employees and residents. One area I do not agree with is where the Veterans Services Officer was placed. I made the case during one of the meetings why it was not a good idea to place the VSO under Public Health and mn.us.

Human Services. Clearly, more work needs to be completed before the final proposal is presented for approval.



The visiting Green Isle Irish baseball team was defeated by the Plato Bluejays 3-2 during the Region 7C Baseball Tournament at Watertown on Saturday morning, Aug. 13. The contest was originally scheduled to be held in Watertown on Friday night, Aug. 12, but was postponed due to rain.

Application deadline for deer lottery is Thursday, Sept. 8

Firearms and muzzleloader hunters who want to harvest antlerless deer in a deer permit area designated as lottery this hunting season are reminded they must purchase their license and apply for an antlerless permit by Thursday, Sept. 8.

This season, antlerless deer permits are issued by lottery in 67 of Minnesota's 128 deer permit areas. Antlerless deer are without an antler at least 3 inches long. No application is needed to take antlerless deer in permit areas designated as hunters choice, managed or intensive harvest

Hunters who want to participate in special firearm deer hunts also need to apply for permits that are issued by lottery, and the application deadline is Sept. 8.

More information on deer permit areas and special hunts is available in the 2016 Minnesota Hunting and Trapping Regulations Handbook, found online on the deer hunting page.

Applications open for nearly \$7 million in Legacy grants

Groups that want to restore, protect or enhance public land can apply for Conservation Partners Legacy (CPL) grants that help pay for work on Minnesota prairies, forests, wetlands or other habitat for fish and wildlife.

Nonprofit organizations and government entities are eligible to submit applications for traditional and metro grant cycles now until 4 p.m., Friday, Sept. 9, on the Minnesota Department of Natural Resources website on the grant program page.

Projects must be on public land or land permanently protected by conservation easements. Applicants may request up to \$400,000 with a total project cost not exceeding \$575,000. Projects must also have a 10 percent match from a source outside a state agency.

In its first seven years of funding, nearly \$38 million has been granted through the CPL program for habitat projects throughout Minnesota. Funding comes from the Outdoor Heritage Fund, which was created after voters approved the Clean Water, Land and Legacy Amendment in 2008.

Three Types of **CPL Grants**

For fiscal year 2017, the Lessard-Sams Outdoor Heritage Council recommended allocating \$3.35 million for the traditional grant cycle, \$2.5 million for the metro grant cycle (for projects located in the seven-county metro area or within the city limits of Duluth, St. Cloud and Rochester) and \$1 million for the Expedited Conservation Projects (ECP) grant cycle. The ECP cycle is open continuously through May 12, 2017, or until funds run out, with the first funding round due Sept. 9.

Zebra mussels are confirmed in 5 Minnesota lakes

The Department of Natural Resources has confirmed five new reports of zebra mussels in central Minnesota lakes.

Infested waters signs have been posted at DNR accesses on West Battle Lake and Otter Tail Lake in Otter Tail County, Lake Florida in Kandiyohi County, Pocket Lake in Douglas County, and a network of abandoned mine pits in Cuyuna Country State Recreation Area in Crow Wing County.

"While any new infestation is serious, it's important to note that more than 98 percent of Minnesota lakes are not listed as infested with zebra mussels," said Ann Pierce, section manager for the DNR's Ecological and Water Resources Division. "Boaters and anglers, DNR-trained watercraft inspectors and enforcement officers, lake associations and many others are working to keep it that way."

DNR invasive species staff found one adult zebra mussel in the area of an initial citizen report and three adult zebra mussels about three miles from the initial report location on West Battle Lake. The DNR will monitor downstream lakes in Glendalough State Park.

A swimmer found a zebra mussel on a native clam in Otter Tail Lake. DNR invasive species staff searched more than 3,000 objects in the lake and did not find any other zebra mussels. They continue to conduct dock and lift searches, and ask the public to check their equipment and contact the DNR to report anything suspicious.

DNR researchers found zebra mussel veligers (larvae) in Lake Florida while doing other work in the lake.

Veligers can be inadvertently but illegally transported in water from an infested lake as ballast, in live wells or in bait water. Boaters and anglers are required by law to open all drain plugs and drain all water when leaving any Minnesota lake or river and to keep drain plugs out during transport.

A swimmer reported a zebra mussel in Pocket Lake. No other zebra mussels were found during extensive snorkel searches by DNR invasive species staff, while connected lakes downstream have had relatively heavy infestations for some time.

Alert divers contacted the DNR upon finding numerous zebra mussels in two abandoned mine pits in the Cuyuna Country State Recreation Area. The DNR is surveying other mine pits in the area. Divers and all lake users are

reminded to carefully clean and check their gear when leaving or entering any lake or moving from pit to pit, whether or not it is infested.

Reports from citizens are frequently the first indication of a new infestation, and the DNR appreciates the partnership of lake users, county watershed districts and lake associations

To protect the state's waters from the spread of invasive species and the environmental, recreational and economic damage they cause, Minnesota law requires boaters and an-







Sibley East School Board tours construction sites in both towns

Sibley East School Board members had the opportunity to tour the building progress of both the Gaylord and Arlington sites on Monday, Aug. 15.

According to Gaylord site manager Rick Kuyava, Gaylord is still approximately four weeks behind schedule. Kuyava stated that the Gavlord project got behind schedule because of the rain, and because the mason crew was short-staffed.

Arlington site manager Michael Beach said that they were "very fortunate to be at this site," that it was a good community, and the community was "solidly behind the project."

In Arlington, the old music and art space will be turned

into an ag and wood shop. Beach said they hope to have the large overhead door for the shop in by Thursday, Sept. 1. Students will be using this space when school starts, but will have to access the area from the outside for a few weeks.

Band and choir will use the choir room in the old elementary portion of the school until Christmas when the new room should be ready. Art classes will also be in the old elementary section of the school for the first half of the school year and also plan to be in the new space by Christmas.

Beach pointed out the new space for math, social studies, and science on the west side of the campus. He also pointed out the large competition size gym that will have di-

viders to separate it into three smaller spaces for a multigym situation. Parking for more than 70 cars will also be added to the north side of the building, and next year parking for approximately 50 cars will be added to the south side of the school.

Beach said that they had to pump out water from the construction site all day on Friday, Aug. 12 and pump over the weekend but stated that it "didn't really slow us down a great deal." They will be unloading panels later this week and hope to start setting planks on Monday. People will notice progress at the Arlington site in the next couple of weeks. Beach said that once they have gas and heat, they will be able to work all winter.
