

## Panther softball looks to clinch WCC West title this week

It's been a dandy spring for the Glencoe-Silver Lake softball team, as the Panthers entered this week on the cusp of clinching the Wright County Conference West title.

After winning three conference games including two against Watertown-Mayer and one versus Dassel-Cokato, GSL began this week firmly perched in the catbird seat atop the WCC West with a 10-2 circuit mark.

The Panthers were able to clinch at least a tie for the conference crown with a win over visiting New London-Spicer on Tuesday, May 14, after the Chronicle went to press.

GSL rode a five-game winning streak into this week after the three WCC West wins and a sweep of the Howard Lake-Waverly-Winsted Tournament on Saturday, May 11. The Panthers topped the host Lakers 7-2 and blanked Pine City 11-0 to win the tourney title.

Watertown-Mayer was swamped by GSL after the Royals came to Glencoe on Tuesday, May 7. The Panthers outscored their visitors 25-5 over the two-game set, winning Game One 10-0 in five innings and then taking Game Two by a score of 15-5.

Pitcher Briana Wrapsir

tossed a pair of complete games on the day. She tossed a five-inning one-hitter in Game One, striking out 10 and walking one, after also going 2-for-3 and accounting for two runs at the plate. Sydney Lepel recorded three RBI, while Miranda Litzau was 2-for-3 with three runs scored.

In Game Two, Wrapsir struck out nine in seven innings, while allowing eight hits, one walk and three earned runs. Litzau and Hannah Boesche both went 3-for-6, with five and three RBI, respectively. Boesche also scored four runs, while Litzau crossed home plate twice. Kasidy Cacka went 4-for-6 with two RBI.

Two days later, the Panthers traveled to Dassel-Cokato and secured a 9-1 win. Wrapsir went all seven innings, striking out 16 batters while allowing six hits, one walk and one earned run. She also had three RBI at the plate and accounted for two runs scored. Litzau went 2-for-5 with three runs scored in the win.

The regular season concludes this week with a home matchup against current WCC West No. 2 team, Litchfield. GSL claimed the first game of the season between the teams, winning 7-3 at Litchfield on April 9. First pitch of the regular-season finale is at 5 p.m. Thursday evening.

A windy, sunny day greeted the competitors as the Glencoe-Silver Lake track and field teams hosted their annual invitational meet on Tuesday, May 7. The Panther girls finished first, while the boys finished second.

Rhyan Herrmann won a pair of individual events, taking the top spot in the 100- and 200-meter dash in respective times of 12.78 and 27.45 seconds. She also took second in the high jump with a leap of four feet, eight inches.

Malayh Metcalf won the 800-meter run in a time of two minutes, 34.82 seconds, while Kendall Guerrero (6:01.76) and Maddie Lemke (6:04.46) placed 1-2 in the 1600-meter run. Lemke (13:15.35), Majkya Metcalf (13:45.23) and Kendra Klobe swept the top three spots, respectively, in the 3200-meter run.

The GSL girls took first in two of four relay events, with the quartet of Ellie Sonju, Rhyan Herrmann, Julia Nelson and Emily Graupmann winning the 4x200-meter relay in 1:49.57 and the four-some of Graupmann, Metcalf, Hope Kosek and Sonju winning 4x400-meter relay in

The Brownton Bruins improved to 3-1 on the season with an 11-1, eight-inning win against visiting St. Boni on Sunday, May 12.

Deryk Randt got the Bruins on the board with a two-run homer in the second inning of Brownton's home opener at Barney Tadsen Field. The blast put the hosts up for good as Bruins starter

Ryan Grams turned in another gem on the mound.

Grams tossed a complete-game four hitter, allowing one unearned run on four hits and one walk while striking out 11 Saints batters.

Randt, Taylor Schuette and Grant Baumetz had two RBI apiece in the victory as Brownton took advantage of eight walks and three St. Boni errors to score 11 runs on just eight hits.

Jon Werner, who scored on Randt's homer, had the Bruins' lone multi-hit day with a 2-for-3 battling line to go with a walk. Werner and Randt each scored twice in the game.

Brownton heads back out on the road this weekend with a 2 p.m. start scheduled at Carver on Saturday and a 4 p.m. first pitch slated at Young America on Sunday.

## GSL baseball in final stretch

A 3-1 stretch last week gave the Glencoe-Silver Lake baseball team a 10-5 overall record heading into the final four-game sequence of the regular season.

The Panthers entered this week in second place in the Wright County Conference West standings with a 7-4 circuit mark, 3-1/2 games behind lead horse Litchfield.

GSL opened last week with a 10-0 shutout victory at Watertown-Mayer, despite logging just six hits.

Starting pitcher Corey Johnson earned the victory after giving up just two hits and two walks over six innings, while recording nine strikeouts. Ty Christensen pitched the seventh, allowing one hit with one strikeout.

The Panthers broke open a 1-0 game with a six-run sixth

inning before finishing off the Royals with a three-run seventh. Bennett Lepel went 1-for-3 with a three-run homer in the sixth. Max Edwards pinch-hit for Lepel in the seventh and had a two-run single.

GSL traveled to Dassel-Cokato for a doubleheader on Thursday, May 9. Each team stole a game with late-inning rallies.

The Chargers won Game One 4-3 on a two-run single in the bottom of the seventh, while the Panthers scored a seventh-inning run in the nightcap to win 2-1.

Christensen pitched 1-2/3 innings in relief of starter Drew Hedtke and earned the win. He won the game for himself by tripling and then scoring the victorious tally on an RBI single by Spencer Lilienthal in the bottom of the seventh.

Remaining on the road,

GSL claimed a 7-2 win at Mayer Lutheran on Friday, May 10. Brett Baumgarten started and earned the victory after allowing three hits, three walks and two earned runs while striking out four in four innings.

Chandler Glaeser went 2-for-3 with one RBI and run scored on a sixth-inning homer. Lepel went 2-for-4 with two RBI and one run scored, while Johnson scored twice for the visitors.

The Panthers headed out to the WCC West's westernmost outpost with a game at New London-Spicer on Tuesday, May 14, after the Chronicle went to press.

GSL is scheduled to return home with a Thursday matchup against Mound Westonka before hosting Howard Lake-Waverly-Winsted on Friday. First pitch in both games is 4:30 p.m.

Zach Meyer led the Panthers by finishing in a third-place tie with a score of 80. Riley Schuth scored an 84, while Reid Coon-Gore's 91 and Jacob Schrupp's 93 filled out GSL's team card of 348. Damien Silus posted a 94, with Derek Trippel recording a 95.

Last week, GSL opened with back-to-back nine hole

conference competitions at Southbrook Golf Course, hosted by Annandale, on Tuesday, May 7. In the first leg, the Panthers finished in a fourth-place tie with New London-Spicer after both teams compiled scores of 163.

Schuth led the team with a 39, followed by Meyer's 40, Riley Schuth scored an 84, while Reid Coon-Gore and Schrupp both posted a 44.

In the second leg, the Panthers took sixth with a 169. Meyer carded a 38, Schuth a 40, Coon-Gore a 45, with Silus and Trippel each posting a 46. Schrupp finished

Mayor Wilson called the regular meeting of the city council to order at 7:00 p.m. Members present: Neid, Schrupp, Robeck, Lemke and Alexander. Also present: City Administrator Mark Larson, City Attorney Ostlund, Ass't City Administrator Ehrke, Finance Director Trippel and Public Works Directors Schreifels and Voigt.

Motion to approve consent agenda as presented entered by Councilor Alexander, with second by Councilor Neid. Motion carried 5-0.

Approve the minutes of the regular meeting of April 1, 2019.

Mayor Wilson opened the public hearing. City Attorney Ostlund reviewed the proposed ordinance to allow the City to handle dangerous dog dispositions in a more practical manner. The amendment allows the animal control officer to elect to pursue the dangerous dog designation under the state statute, rather than city ordinance. Under the state statute, the city can then appoint a neutral party to act as the judge.

Public input concerned the cause of the dogs reaction to be considered. What and who incited the dog and was there previous history of person filing complaint regarding the dog. City Attorney Ostlund stated that this is the essence of why there is a hearing conducted.

Motion to close the public hearing entered by Member Alexander and seconded by Member Neid. Motion carried in 5-0 vote.

Motion to approve the second reading of Ordinance No. 604 Dangerous Dog Ordinance Amendment entered by Councilor Neid with second by Councilor Lemke. All members voted in favor.

Assistant City Administrator Dan Ehrke reviewed the proposal to renovate the original restrooms in the west wing of the main floor of the City Center. Rice Builders provided the cost estimate and floor plans for finishing the restrooms as requested by city staff and these were presented at the recent council workshop.

Private donations to date total \$26,190 for completion of this project. The Hoese Family Foundation will match \$0.25 for every \$.075 raised by the city to complete this project with a cap of \$25,000. Proposed financing to complete the estimated \$132,000 project also includes a City general fund contribution on \$50,000 leaving the additional private donations needing to be solicited at approximately \$30,810.

Discussion led to Member Alexander motioning to approve the project and authorize the funding efforts with the city contributing \$50,000 and contingent upon the fundraising to contribute the balance of the funds needed. Councilor Schrupp seconded the motion. Motion carried on a 5-0 vote.

Public Works Director Schreifels presented the quotes to vector and televise the north trunk sewer main from Pryor Avenue to the East entrance of Coborn's on Morningside Avenue.

It was recommended to award the project to the low bidder, Pipe Services in the amount of \$6,865.30. The 2019 budget reflects the approval in the amount of \$10,000 for this serv-

ice.

Councilor Lemke entered the motion approving the low quote of Pipe Services in the amount of \$6,865.30. Councilor Alexander seconded the motion. All members voted in favor.

Councilor Lemke motioned to approve appointing Craig Miller to the Library Board open position. Councilor Schrupp seconded the motion. Member Robeck wanted this brought to the Library Board for consideration and to follow Charter and protocol for appointing members. The Head Librarian was informed of the applicant and gave the go ahead to put on the agenda. The position has been open for more than a year. This has been the only applicant to date for the position.

Members voting in favor of the motion were Schrupp, Lemke and Neid. Robeck and Alexander voted no. Motion carried.

City Administrator Mark Larson reviewed the Transaction Form to Withdraw Credits for the Minnesota Wetland Bank Program to be used in the Harpel's East Development for the pond. The cost of the credits is \$29,437.43 and will be included in the assessments against the property beginning in 2020.

Councilor Schrupp entered the motion to authorize the City Administrator to execute the transaction Form to Withdraw Credits from the Minnesota Wetland Bank Program. Councilor Neid seconded. The motion carried on a 5-0 vote.

City Administrator reviewed the 4 year seal coat plan and funding sources to be considered for the plan. The 2019 seal coat is for the Glenview Woods and Glenview Estates, City Center parking lot and the 2014 Street Improvement Project area. Total estimated costs for these areas is \$236,000.

Councilor Lemke motioned to approve the 4-year Seal Coat Plan and authorize the City Engineer to solicit bids for the 2019 project. Councilor Neid seconded. All members voted in favor.

City Attorney Mark Ostlund presented the joint resolution with Glencoe Township to annex property owned by McLeod County for the Morningside roundabout. The parcel needs to be annexed for certain grant eligibility reasons. Glencoe Township will be approving this resolution at their meeting tonight.

Councilor Robeck entered the following resolution and moved for its adoption:

Councilor Neid seconded. Upon a roll call vote members voting in favor were Neid, Lemke, Robeck and Alexander. Councilor Schrupp entered a no vote. Whereupon said resolution was adopted and approved in a 4 to 1 vote.

City Attorney Mark Ostlund reviewed the letter from Greg Wedin regarding access to his property in the Central Storm Sewer Project area. He

is requesting of the City to have his driveway competed in full when the concrete work on 12th Street is done this spring at no cost to him. He is requesting this due to the significant inconvenience he has experienced in accessing his property due to the construction project in the area.

The City Attorney drafted a letter in response to the request stating the City cannot provide the compensation requested. There is nothing to suggest that the impact of the project on his property has risen to the level of a government taking. Thus no just compensation is owed as a matter of law. As a practical matter, the City simply

does not have the resources to voluntarily compensate citizens who are temporarily impacted by infrastructure improvements.
