Annual rivalry is watered down

The annual rivalry game between the Plato Blue Jays and Glencoe Brewers was not without suspense this year.

Heavy rains Friday night had fans watching tarp crews in action instead of ball players, as the game was postponed in the top of the third inning with two outs and a man on first.

That didn't stop Plato from taking a 4-0 lead in the first inning with some solid hitting.

Kyle Panning took a six-pitch walk from Brewers' pitcher Jaime Paumen before advancing to second on Nick Johnson's sacrifice bunt.

Matt Odegaard hit an RBI single to right field, scoring Panning. Eric Engelmann walked in the next at bat, before Adam Prehn sent a three-run homer over the left-field fence.

With rain pooling along the baselines in the top of the third, the game was called and resumed Thursday night with a number of players missing, or in different positions. The same audience, atmosphere and chirping also were ab-

Colt Trebesch replaced Paumen on the mound for Glencoe, and kept Plato scoreless for 1-1/3 inning.

Odegaard took the hill in place of Wischnack for Plato, and only gave up two hits in five innings to the Brewer

Odegaard and Prehn scored in the fifth to make it 6-0 Plato, with Brian Graupmann and Joe Nix notching the

The seventh and final run came in the top of the sixth, as Odegaard sent Trebesch's fifth pitch for a solo-shot over the left-center fence.

Lang came in for Odegaard in the eighth and retired three straight batters on strikes. He picked up where he left off in the ninth, catching Brody Bratsch looking before Marc Wawrzyniak nearly took his head off with a line drive. Lang instinctively raised his glove to protect himself and ended up snatching the ball for the second out.

Lang then proceeded to strike out Tony Paggen on four pitches as the game ended on a backwards K.

Wischnack, Odegaard and Lang combined for 13 strike outs, gave up two hits, no runs and no walks.

The Brewers never went deeper than five pitches in any at bat, and

were retired one, two, three in every inning except for the sixth and sev-

"These guys are starting to really pick it up, realizing that we've only got 11 games in right now, and we've got a 21-game schedule," Plato manager Adam Dammann said. "We've pretty much three weeks before it's the end of the season. So it's nice to see the guys getting hot right now."

Brewers co-manager Matt Godel spoke of the difference in the atmosphere of a game normally full of tension and excitement. That just didn't feel like the classic Glencoe vs. Plato rivalry, he said.

"It's tough to go down right away and then come back four days later and restart," Godel said. "When you play in just a normal setting, it's just not the same ... it's almost like we had to play instead of wanting to.

"You're used to starting a game 0-0, but when you're down and it's already the third inning, it's tough to get back in the game."

Bruins lose one, win one, both by one run, over the weekend

The Brownton Bruins played two close Crow River Valley League (CRVL) games over the weekend, losing by one run to the South Division leader, Young America, Friday night, and then winning by one run over the Plato Bluejays Saturday afternoon.

Brownton took an early lead over Young America Friday night by scoring a run in the first and two in the second for a 3-0 start.

In the first inning, Spencer Glaeser led off with a single, advanced to second on a Ryan Grams base hit, and reached third on a sacrifice bunt by Bryant Nordby. He scored when Nick Heller grounded out to the second baseman.

In the second inning, Chad Genz and Matt Schwichtenberg had back-to-back singles to put two runners on base, and both advanced on a sacrifice bunt by Deryk Randt. Glaeser hit his second single of the game to score Genz, and Schwichtenberg scored on a sacrifice fly to center by Grams.

The Bruins pushed their lead to 4-0 with a run in the top of the sixth as Grams doubled and scored on a two-out single by Taylor Schuette.

The Cardinals, however, rallied for four runs in the bottom of the sixth to knot the score at 4-4, with two runs scoring on a one-out, bases-loaded double by Jon Werner.

Brownton took the lead back, 5-4, with a run in the eighth, with Nordby scoring on Schuette's sacrifice fly to left field.

The Bruins' lead held until the bottom of the ninth. With one out, the Cardinals' Aaron Cook walked. Brownton recorded a second out, but then walked Chet Maschke to put two runners on base. A third walk loaded the bases, and two consecutive Bruins' errors allowed the Cardinals to score the tying and winning runs without the benefit of a hit, taking the game 6-5.

Grams was tagged with the loss for Brownton in a complete-game effort, giving up six runs (two earned) on eight hits. He struck out six and walked four.

Nik Franck and Cook had two hits each for Young America.

The kids were paying attention. Many came up to her afterward to shake her hand, and ask for an autograph or a picture. Others were eager to tell an olympian about their own training regimen and accolades, and she was all too happy to listen and offer words of encour-

agement. She even bantered back and and other classic movies. It was refreshing to meet

someone who has accomplished so much, gone so far, and talks to you like you are old pals even though you've never met before.

Smock said coming back to a small town in rural Minnesota to talk to kids about her experiences helps put things into perspective.

"Looking back at where I've come from, and where I've been — competing in the Olympic games and being crowned the top triple jumper in the nation — it's because I'm from a small town that it brings me back," Smock said. "It kind of brings it full circle a bit, and I enjoy that."

Hopefully, it's one of the kids that she spoke to Tuesday night that is giving the same type of speech after the next Olympic Games in 2016.
